RESOLUTION

Providing for consideration of the bill (H.R. 3017) to amend the Comprehensive Environmental Response, Compensation, and Liability Act of 1980 to reauthorize and improve the brownfields program, and for other purposes, and providing for consideration of the bill (H.R. 3905) to require congressional approval of any mineral withdrawal or monument designation involving the National Forest System lands in the State of Minnesota, to pro-

vide for the renewal of certain mineral leases in such lands, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 3017) to amend the Comprehensive Environmental Re-
4 sponse, Compensation, and Liability Act of 1980 to reau-
5 thorize and improve the brownfields program, and for
6 other purposes. All points of order against consideration
7 of the bill are waived. An amendment in the nature of
8 a substitute consisting of the text of Rules Committee
9 Print 115-40 shall be considered as adopted. The bill, as
10 amended, shall be considered as read. All points of order
11 against provisions in the bill, as amended, are waived. The
12 previous question shall be considered as ordered on the
13 bill, as amended, and on any further amendment thereto,
14 to final passage without intervening motion except: (1) one
15 hour of debate equally divided and controlled by the chair
16 and ranking minority member of the Committee on En-
17 ergy and Commerce; and (2) one motion to recommit with
18 or without instructions.

19 SEC. 2. Upon adoption of this resolution it shall be
20 in order to consider in the House the bill (H.R. 3905)
21 to require congressional approval of any mineral with-
22 drawal or monument designation involving the National
23 Forest System lands in the State of Minnesota, to provide
24 for the renewal of certain mineral leases in such lands,

1 and for other purposes. All points of order against consid-
2 eration of the bill are waived. An amendment in the nature
3 of a substitute consisting of the text of Rules Committee
4 Print 115-41 shall be considered as adopted. The bill, as
5 amended, shall be considered as read. All points of order
6 against provisions in the bill, as amended, are waived. The
7 previous question shall be considered as ordered on the
8 bill, as amended, and on any further amendment thereto,
9 to final passage without intervening motion except: (1) one
10 hour of debate equally divided and controlled by the chair
11 and ranking minority member of the Committee on Nat-
12 ural Resources; (2) the further amendment printed in the
13 report of the Committee on Rules accompanying this reso-
14 lution, if offered by the Member designated in the report,
15 which shall be in order without intervention of any point
16 of order, shall be considered as read, shall be separately
17 debatable for the time specified in the report equally di-
18 vided and controlled by the proponent and an opponent,
19 and shall not be subject to a demand for a division of the
20 question; and (3) one motion to recommit with or without
21 instructions.
