Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4) to reauthorize programs of the Federal Aviation Administration, and for other purposes; providing for consideration of the bill (H.R. 3144) to provide for operations of the Federal Columbia River Power System pursuant to a certain operation plan for a specified period of time, and for other purposes; and providing for proceedings during the period from April 30, 2018, through May 4, 2018.

1 *Resolved*, That (a) at any time after adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4) to reauthorize programs of the
6 Federal Aviation Administration, and for other purposes.
7 The first reading of the bill shall be dispensed with. All
8 points of order against consideration of the bill are waived.
9 General debate shall be confined to the bill and shall not
10 exceed one hour equally divided and controlled by the chair
11 and ranking minority member of the Committee on Trans-
12 portation and Infrastructure. After general debate the bill
13 shall be considered for amendment under the five-minute
14 rule. The bill shall be considered as read. All points of
15 order against provisions in the bill are waived.

16 (b) No amendment to the bill shall be in order except
17 those printed in part A of the report of the Committee
18 on Rules accompanying this resolution and amendments
19 en bloc described in subsection (e).

20 (c) Each amendment printed in part A of the report
21 of the Committee on Rules shall be considered only in the
22 order printed in the report, may be offered only by a Mem-
23 ber designated in the report, shall be considered as read,
24 shall be debatable for the time specified in the report
25 equally divided and controlled by the proponent and an

1 opponent, shall not be subject to amendment, and shall
2 not be subject to a demand for division of the question
3 in the House or in the Committee of the Whole.

4 (d) All points of order against amendments printed
5 in part A of the report of the Committee on Rules or
6 amendments en bloc described in subsection (e) are
7 waived.

8 (e) It shall be in order at any time for the chair of
9 the Committee on Transportation and Infrastructure or
10 his designee to offer amendments en bloc consisting of
11 amendments printed in part A of the report of the Com-
12 mittee on Rules not earlier disposed of. Amendments en
13 bloc offered pursuant to this subsection shall be considered
14 as read, shall be debatable for 20 minutes equally divided
15 and controlled by the chair and ranking minority member
16 of the Committee on Transportation and Infrastructure
17 or their designees, shall not be subject to amendment, and
18 shall not be subject to a demand for division of the ques-
19 tion in the House or in the Committee of the Whole.

20 (f) At the conclusion of consideration of the bill for
21 amendment the Committee shall rise and report the bill
22 to the House with such amendments as may have been
23 adopted. The previous question shall be considered as or-
24 dered on the bill and amendments thereto to final passage

1 without intervening motion except one motion to recommit
2 with or without instructions.

3 SEC. 2. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 3144)
5 to provide for operations of the Federal Columbia River
6 Power System pursuant to a certain operation plan for
7 a specified period of time, and for other purposes. All
8 points of order against consideration of the bill are waived.
9 The amendment printed in part B of the report of the
10 Committee on Rules accompanying this resolution shall be
11 considered as adopted. The bill, as amended, shall be con-
12 sidered as read. All points of order against provisions in
13 the bill, as amended, are waived. The previous question
14 shall be considered as ordered on the bill, as amended,
15 and on any further amendment thereto, to final passage
16 without intervening motion except: (1) one hour of debate
17 equally divided and controlled by the chair and ranking
18 minority member of the Committee on Natural Resources;
19 and (2) one motion to recommit with or without instruc-
20 tions.

21 SEC. 3. On any legislative day during the period from
22 April 30, 2018, through May 4, 2018 —

23 (a) the Journal of the proceedings of the previous day
24 shall be considered as approved; and

1 (b) the Chair may at any time declare the House ad-
2 journed to meet at a date and time, within the limits of
3 clause 4, section 5, article I of the Constitution, to be an-
4 nounced by the Chair in declaring the adjournment.

5 SEC. 4. The Speaker may appoint Members to per-
6 form the duties of the Chair for the duration of the period
7 addressed by section 3 of this resolution as though under
8 clause 8(a) of rule I.
