Mr. NEWHOUSE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3053) to amend the Nuclear Waste Policy Act of 1982, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3053) to amend the Nuclear Waste
6 Policy Act of 1982, and for other purposes. The first read-
7 ing of the bill shall be dispensed with. All points of order

1 against consideration of the bill are waived. General de-
2 bate shall be confined to the bill and shall not exceed one
3 hour equally divided and controlled by the chair and rank-
4 ing minority member of the Committee on Energy and
5 Commerce. After general debate the bill shall be consid-
6 ered for amendment under the five-minute rule. In lieu
7 of the amendment in the nature of a substitute rec-
8 ommended by the Committee on Energy and Commerce
9 now printed in the bill, it shall be in order to consider
10 as an original bill for the purpose of amendment under
11 the five-minute rule an amendment in the nature of a sub-
12 stitute consisting of the text of Rules Committee Print
13 115-69. That amendment in the nature of a substitute
14 shall be considered as read. All points of order against
15 that amendment in the nature of a substitute are waived.
16 No amendment to that amendment in the nature of a sub-
17 stitute shall be in order except those printed in the report
18 of the Committee on Rules accompanying this resolution.
19 Each such amendment may be offered only in the order
20 printed in the report, may be offered only by a Member
21 designated in the report, shall be considered as read, shall
22 be debatable for the time specified in the report equally
23 divided and controlled by the proponent and an opponent,
24 shall not be subject to amendment, and shall not be sub-
25 ject to a demand for division of the question in the House

1 or in the Committee of the Whole. All points of order
2 against such amendments are waived. At the conclusion
3 of consideration of the bill for amendment the Committee
4 shall rise and report the bill to the House with such
5 amendments as may have been adopted. Any Member may
6 demand a separate vote in the House on any amendment
7 adopted in the Committee of the Whole to the bill or to
8 the amendment in the nature of a substitute made in order
9 as original text. The previous question shall be considered
10 as ordered on the bill and amendments thereto to final
11 passage without intervening motion except one motion to
12 recommit with or without instructions.
