Ms. CHENEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 6157) making appropriations for the Department of Defense for the fiscal year ending September 30, 2019, and for other purposes, and providing for consideration of the bill (H.R. 2083) to amend the Marine Mammal Protection Act of 1972 to reduce predation on endangered Columbia River salmon and other nonlisted species, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 6157) making appropriations for  
6 the Department of Defense for the fiscal year ending Sep-  
7 tember 30, 2019, and for other purposes. The first reading  
8 of the bill shall be dispensed with. All points of order  
9 against consideration of the bill are waived. General de-  
10 bate shall be confined to the bill and shall not exceed one  
11 hour equally divided and controlled by the chair and rank-  
12 ing minority member of the Committee on Appropriations.  
13 After general debate the bill shall be considered for  
14 amendment under the five-minute rule. An amendment in  
15 the nature of a substitute consisting of the text of Rules  
16 Committee Print 115-77 shall be considered as adopted  
17 in the House and in the Committee of the Whole. The  
18 bill, as amended, shall be considered as the original bill  
19 for the purpose of further amendment under the five-  
20 minute rule and shall be considered as read. Points of  
21 order against provisions in the bill, as amended, for failure  
22 to comply with clause 2 of rule XXI are waived except  
23 as follows: page 86, line 1, through page 86, line 7. No  
24 further amendment to the bill, as amended, shall be in  
25 order except those printed in part A of the report of the

1 Committee on Rules accompanying this resolution and pro  
2 forma amendments described in section 3 of this resolu-  
3 tion. Each further amendment printed in part A of the  
4 report shall be considered only in the order printed in the  
5 report, may be offered only by a Member designated in  
6 the report, shall be considered as read, shall be debatable  
7 for the time specified in the report equally divided and  
8 controlled by the proponent and an opponent, shall not  
9 be subject to amendment except as provided by section 3  
10 of this resolution, and shall not be subject to a demand  
11 for division of the question in the House or in the Com-  
12 mittee of the Whole. All points of order against such fur-  
13 ther amendments are waived. At the conclusion of consid-  
14 eration of the bill for amendment pursuant to this resolu-  
15 tion, the Committee of the Whole shall rise without mo-  
16 tion. No further consideration of the bill shall be in order  
17 except pursuant to a subsequent order of the House.

18       SEC. 2. At any time after adoption of this resolution  
19 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
20 declare the House resolved into the Committee of the  
21 Whole House on the state of the Union for consideration  
22 of the bill (H.R. 2083) to amend the Marine Mammal Pro-  
23 tection Act of 1972 to reduce predation on endangered  
24 Columbia River salmon and other nonlisted species, and  
25 for other purposes. The first reading of the bill shall be

1 dispensed with. All points of order against consideration  
2 of the bill are waived. General debate shall be confined  
3 to the bill and shall not exceed one hour equally divided  
4 and controlled by the chair and ranking minority member  
5 of the Committee on Natural Resources. After general de-  
6 bate the bill shall be considered for amendment under the  
7 five-minute rule. It shall be in order to consider as an  
8 original bill for the purpose of amendment under the five-  
9 minute rule an amendment in the nature of a substitute  
10 consisting of the text of Rules Committee Print 115-79.  
11 That amendment in the nature of a substitute shall be  
12 considered as read. All points of order against that amend-  
13 ment in the nature of a substitute are waived. No amend-  
14 ment to that amendment in the nature of a substitute  
15 shall be in order except those printed in part B of the  
16 report of the Committee on Rules accompanying this reso-  
17 lution. Each such amendment may be offered only in the  
18 order printed in the report, may be offered only by a Mem-  
19 ber designated in the report, shall be considered as read,  
20 shall be debatable for the time specified in the report  
21 equally divided and controlled by the proponent and an  
22 opponent, shall not be subject to amendment, and shall  
23 not be subject to a demand for division of the question  
24 in the House or in the Committee of the Whole. All points  
25 of order against such amendments are waived. At the con-

1 clusion of consideration of the bill for amendment the  
2 Committee shall rise and report the bill to the House with  
3 such amendments as may have been adopted. Any Member  
4 may demand a separate vote in the House on any amend-  
5 ment adopted in the Committee of the Whole to the bill  
6 or to the amendment in the nature of a substitute made  
7 in order as original text. The previous question shall be  
8 considered as ordered on the bill and amendments thereto  
9 to final passage without intervening motion except one  
10 motion to recommit with or without instructions.

11 SEC. 3. During consideration of H.R. 6157 for  
12 amendment, the chair and ranking minority member of  
13 the Committee on Appropriations or their respective des-  
14 ignees may offer up to 10 pro forma amendments each  
15 at any point for the purpose of debate.

16 SEC. 4. (a) During consideration of H.R. 6157, it  
17 shall not be in order to consider an amendment proposing  
18 both a decrease in an appropriation designated pursuant  
19 to section 251(b)(2)(A)(ii) of the Balanced Budget and  
20 Emergency Deficit Control Act of 1985 and an increase  
21 in an appropriation not so designated, or vice versa. (b)  
22 This paragraph shall not apply to an amendment between  
23 the Houses.

24 SEC. 5. House Resolution 952 is laid on the table.
