Ms. CHENEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for further consideration of the bill (H.R. 6157) making appropriations for the Department of Defense for the fiscal year ending September 30, 2019, and for other purposes, and providing for proceedings during the period from June 29, 2018, through July 9, 2018.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for further
5 consideration of the bill (H.R. 6157) making appropria-

1 tions for the Department of Defense for the fiscal year
2 ending September 30, 2019, and for other purposes. No
3 further amendment to the bill, as amended, shall be in
4 order except those printed in the report of the Committee
5 on Rules accompanying this resolution and available pro
6 forma amendments described in section 3 of House Reso-
7 lution 961. Each further amendment printed in the report
8 of the Committee on Rules shall be considered only in the
9 order printed in the report, may be offered only by a Mem-
10 ber designated in the report, shall be considered as read,
11 shall be debatable for the time specified in the report
12 equally divided and controlled by the proponent and an
13 opponent, shall not be subject to amendment except
14 amendments described in section 3 of House Resolution
15 961, and shall not be subject to a demand for division
16 of the question in the House or in the Committee of the
17 Whole. All points of order against such further amend-
18 ments are waived. At the conclusion of consideration of
19 the bill for amendment the Committee shall rise and re-
20 port the bill, as amended, to the House with such further
21 amendments as may have been adopted. The previous
22 question shall be considered as ordered on the bill and
23 amendments thereto to final passage without intervening
24 motion except one motion to recommit with or without in-
25 structions.

1 SEC. 2. On any legislative day during the period from
2 June 29, 2018, through July 9, 2018 —

3 (a) the Journal of the proceedings of the pre-
4 vious day shall be considered as approved; and

5 (b) the Chair may at any time declare the
6 House adjourned to meet at a date and time, within
7 the limits of clause 4, section 5, article I of the Con-
8 stitution, to be announced by the Chair in declaring
9 the adjournment.

10 SEC. 3. The Speaker may appoint Members to per-
11 form the duties of the Chair for the duration of the period
12 addressed by section 2 of this resolution as though under
13 clause 8(a) of rule I.

14 SEC. 4. It shall be in order without intervention of
15 any point of order to consider concurrent resolutions pro-
16 viding for adjournment during the month of July, 2018.
