## A BILL

To amend title 38, United States Code, to improve the enrollment of veterans in certain courses of education, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans Education  
5 Priority Enrollment Act of 2017”.

6 **SEC. 2. PRIORITY ENROLLMENT FOR VETERANS IN CER-**  
7 **TAIN COURSES OF EDUCATION.**

8 (a) IN GENERAL.—Subchapter II of chapter 36 of  
9 title 38, United States Code, is amended by inserting after  
10 section 3680A the following new section:

1 **“§ 3680B. Priority enrollment in certain courses**

2       “(a) IN GENERAL.—With respect to an educational  
3 assistance program provided for in chapter 30, 31, 32, 33,  
4 or 35 of this title or chapter 1606 or 1607 of title 10,  
5 if an educational institution administers a priority enroll-  
6 ment system that allows certain students to enroll in  
7 courses earlier than other students, the Secretary or a  
8 State approving agency may not approve a program of  
9 education offered by such institution unless such institu-  
10 tion allows a covered individual to enroll in courses at the  
11 earliest possible time pursuant to such priority enrollment  
12 system.

13       “(b) COVERED INDIVIDUAL DEFINED.—In this sec-  
14 tion, the term ‘covered individual’ means an individual  
15 using educational assistance under chapter 30, 31, 32, 33,  
16 or 35 of this title or chapter 1606 or 1607 of title 10,  
17 including—

18               “(1) a veteran;

19               “(2) a member of the Armed Forces serving on  
20 active duty or a member of a reserve component (in-  
21 cluding the National Guard);

22               “(3) a dependent to whom such assistance has  
23 been transferred pursuant to section 3319 of this  
24 title; and

25               “(4) any other individual using such assist-  
26 ance.”.

1           (b) CLERICAL AMENDMENT.—The table of sections  
2 at the beginning of such chapter is amended by inserting  
3 after the item relating to section 3680A the following new  
4 item:

“3680B. Priority enrollment in certain courses.”.
