A BILL

To amend the Outer Continental Shelf Lands Act to prohibit the Secretary of the Interior including in any leasing program certain planning areas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Coastal and Marine
5 Economies Protection Act”.

6 **SEC. 2. PROHIBITION ON LEASING IN CERTAIN PLANNING**
7 **AREAS.**

8 Section 18 of the Outer Continental Shelf Lands Act
9 is amended by redesignating subsections (g) and (h) as
10 subsections (h) and (i) respectively, and by inserting after
11 subsection (f) the following:

12 “(g) The Secretary shall not include in any leasing
13 program under this section any area within the Atlantic
14 Region planning areas or the Pacific Region planning
15 areas, as such planning areas are described in the docu-
16 ment entitled ‘Draft Proposed Program Outer Continental
17 Shelf Oil and Gas Leasing Program 2019–2024’, dated
18 January 2018.”.
