1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Access to Sufficient
5 Capital for Everyone in Natural Disaster areas Act of
6 2019” or the “ASCEND Act of 2019”.

7 **SEC. 2. COLLATERAL REQUIREMENTS FOR DISASTER**
8 **LOANS UNDER THE SMALL BUSINESS ACT.**

9 (a) AMENDMENT TO THE RISE AFTER DISASTER
10 ACT OF 2015.—Section 2102 of the RISE After Disaster

1 Act of 2015 (Public Law 114–88) is amended be striking
2 subsections (b) and (c).

3 (b) EFFECTIVE DATE.—The amendment made by
4 subsection (a) shall take effect as though enacted as part
5 of the RISE After Disaster Act of 2015.
