## A BILL

To authorize the Secretary of State to provide funds for a United States pavilion at Expo 2020 Dubai, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Expositions Provide  
5 Opportunities Act of 2019” or “EXPO Act of 2019”.

6 **SEC. 2. STATE DEPARTMENT AUTHORIZATION FOR PAVIL-**  
7 **ION AT EXPO 2020 DUBAI.**

8 (a) IN GENERAL.—Notwithstanding section 204 of  
9 the Admiral James W. Nance and Meg Donovan Foreign

1 Relations Authorization Act, Fiscal Years 2000 and 2001  
2 (22 U.S.C. 2452b), the Secretary of State is authorized,  
3 subject to subsections (b) and (c) of this section, to pro-  
4 vide funds for a United States pavilion at Expo 2020  
5 Dubai.

6 (b) NOTIFICATION.—No funds made available to the  
7 Department of State to be used for a pavilion at Expo  
8 2020 Dubai may be obligated or expended unless the ap-  
9 propriate congressional committees are notified not less  
10 than 15 days prior to such obligation or expenditure.

11 (c) REPORT.—The Secretary of State may not pro-  
12 vide funds for a United States pavilion at Expo 2020  
13 Dubai unless, not later than the date that is 180 days  
14 before such pavilion is opened, the Secretary of State sub-  
15 mits to the appropriate congressional committees a report  
16 concerning activities relating to such pavilion, including—

17 (1) a description of the source of such funds,  
18 including any funds reprogrammed or transferred by  
19 the Department of State to be made available for  
20 such pavilion;

21 (2) an estimate of the amount of investment  
22 such pavilion could bring to the United States;

23 (3) an analysis of the human rights record of  
24 the United Arab Emirates; and

1           (4) a certification that each entity receiving  
2 amounts for a contract, grant, or other agreement to  
3 construct, maintain, or otherwise service such pavil-  
4 ion is not in violation of the labor laws of the United  
5 Arab Emirates and do not employ, or otherwise uti-  
6 lize, a victim of trafficking (as defined in section 103  
7 of the Trafficking Victims Protection Act of 2000  
8 (22 U.S.C. 7102)).

9           (d) APPROPRIATE CONGRESSIONAL COMMITTEES  
10 DEFINED.—In this section, the term “appropriate con-  
11 gressional committees” means the following:

12           (1) The Committee on Foreign Affairs and the  
13 Committee on Appropriations of the House of Rep-  
14 resentatives.

15           (2) The Committee on Foreign Relations and  
16 the Committee on Appropriations of the Senate.

17           (e) SUNSET.—This section ceases to be effective on  
18 September 30, 2021.
