A BILL

To rescind certain appropriations made in the Coronavirus Aid, Relief, and Economic Security Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Working Under Hu-
5 manity’s Actual Needs Rescissions Act” or the “WUHAN
6 Rescissions Act”.

1 **SEC. 2. RESCINDING CERTAIN APPROPRIATIONS IN THE**
2 **CARES ACT.**

3 (a) DEPARTMENT OF COMMERCE.—Of the unobli-
4 gated balances made available to the Department of Com-
5 merce under title II of division B of the Coronavirus Aid,
6 Relief, and Economic Security Act, 2020 (Public Law
7 116–136), \$20,000,000 from “National Institute of
8 Standards and Technology—National Oceanic and Atmos-
9 pheric Administration—Operations, Research, and Facili-
10 ties” are rescinded.

11 (b) DEPARTMENT OF JUSTICE.—The following unob-
12 ligated balances made available to the Department of Jus-
13 tice under title II of division B of the Coronavirus Aid,
14 Relief, and Economic Security Act, 2020 (Public Law
15 116–136) are rescinded:
