## A BILL

To defer removal of nationals of Haiti during the COVID-19 emergency period, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Haitian Deportation  
5 Relief Act”.

6 **SEC. 2. DEFERRAL OF REMOVAL TO HAITI.**

7 (a) IN GENERAL.—An alien may not be removed dur-  
8 ing the period described in subsection (b) if the alien—

1 (1) is a national of Haiti;

2 (2) has been ordered removed at any time be-  
3 fore, on, or after the date of enactment of this Act;  
4 and

5 (3) is physically present in the United States on  
6 such date of enactment.

7 (b) PERIOD.—The period described in this subsection  
8 shall begin on the date of enactment of this Act and end  
9 on the date that is the later of—

10 (1) the date on which the emergency period de-  
11 scribed in section 1135(g)(1)(B) of the Social Secu-  
12 rity Act (42 U.S.C. 1320b–5(g)(1)(B)) expires; or

13 (2) the date on which the Secretary of Home-  
14 land Security, in consultation with the Secretary of  
15 State and the Secretary of Health and Human Serv-  
16 ices, submits to Congress a written report assessing  
17 the spread of COVID-19 in Haiti and certifying  
18 that—

19 (A) the emergency in Haiti with respect to  
20 COVID-19 has ended;

21 (B) there is not a risk of community trans-  
22 mission of COVID-19 in Haiti; and

23 (C) Haiti’s public health infrastructure is  
24 not at risk of being overburdened by patients  
25 suspected of having contracted COVID-19.

1           (c) ALTERNATIVES TO DETENTION PROGRAM.—The  
2 Secretary of Homeland Security shall prioritize for alter-  
3 natives to detention an alien whose removal is deferred  
4 pursuant to this Act, unless the Secretary determines that  
5 such alien would pose a significant risk to public safety  
6 if released into the interior.

7           (d) COVID-19 DEFINED.—In this Act, the term  
8 “COVID-19” means Coronavirus Disease 2019.
