## A BILL

To provide Peace Corps volunteers and trainees whose service was terminated as a result of the COVID–19 pandemic with health insurance, an expedited redeployment process, and domestic service opportunities, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Utilizing and Sup-  
5 porting Evacuated Peace Corps Volunteers Act”.

1   **SEC. 2. HEALTH INSURANCE CONTINUATION FOR PEACE**

2                   **CORPS VOLUNTEERS.**

3                 Section 5(e) of the Peace Corps Act (22 U.S.C.

4 2504(e)) is amended—

5                   (1) by striking “Volunteers shall receive such

6                 health care” and inserting the following:

7                   “(1) Volunteers shall receive such health care”;

8                 and

9                   (2) by adding at the end the following new

10                 paragraphs:

11                  “(2) Volunteers whose periods of service were  
12                 subject to early termination as a result of the  
13                 COVID–19 public health emergency declared under  
14                 section 319 of the Public Health Service Act (42  
15                 U.S.C. 247d), and applicants for enrollment de-  
16                 scribed in section 8(a) whose training prior to enroll-  
17                 ment was subject to early termination as a result of  
18                 such public health emergency, shall receive—

19                  “(A) 2 months of health insurance upon  
20                 their return to the United States; and

21                  “(B) an opportunity to extend such health  
22                 insurance, at the expense of such volunteer or  
23                 applicant for enrollment, until the last day of  
24                 the last week for which such volunteer or appli-  
25                 cant for enrollment is eligible for payments

1           under section 2102 of the CARES Act (Public  
2           Law 116–136).

3           “(3) Not later than 30 days prior to the date  
4           on which the period of service of a volunteer shall  
5           terminate, the Director of the Peace Corps, in con-  
6           sultation with the Secretary of Health and Human  
7           Services, shall provide general guidance to such vol-  
8           unteer on options for health care after termination  
9           other than health care provided by the Peace Corps,  
10           including—

11           “(A) on the application process and eligi-  
12           bility requirements for medical assistance under  
13           State plans under title XIX of the Social Secu-  
14           rity Act (or waivers of State plans);

15           “(B) on the qualified health plans (as de-  
16           fined in section 1301(a) of the Patient Protec-  
17           tion and Affordable Care Act (42 U.S.C.  
18           18021(a))) offered through an Exchange estab-  
19           lished under title I of such Act, including on  
20           the enrollment periods for enrolling in such  
21           plans; and

22           “(C) in the case such volunteer is 25 years  
23           of age or younger, that such volunteer may be  
24           eligible to enroll as a dependent child in a  
25           group health plan or health insurance coverage

1           in which the parent of such volunteer is enrolled  
2           if such plan or coverage offers such dependent  
3           coverage.”.

4 **SEC. 3. EXPEDITED HIRING FOR PEACE CORPS VOLUN-**  
5           **TEERS.**

6       (a) NONCOMPETITIVE ELIGIBILITY HIRING STA-  
7 TUS.—

8           (1) DISTRIBUTION OF INFORMATION.—Not  
9           later than 30 days after the date of enactment of  
10          this Act, and annually thereafter, the Director of the  
11          Office of Personnel Management, in coordination  
12          with the Director of the Peace Corps, shall prepare  
13          and distribute information to each Federal depart-  
14          ment and agency in the executive branch regarding  
15          the noncompetitive appointment eligibility available  
16          to Peace Corps volunteers for up to 3 years under  
17          Executive Order 11103 (22 U.S.C. 2504 note; relat-  
18          ing to Providing for the Appointment of Former  
19          Peace Corps volunteers to the Civilian Career Serv-  
20          ices), as amended by Executive Order 12107 (44  
21          Fed. Reg. 1055; relating to the Civil Service Com-  
22          mission and Labor-Management in the Federal Serv-  
23          ice), including the qualifications for such eligibility.

24           (2) EXPEDITED PROCESS.—Each Federal de-  
25          partment and agency in the executive branch facing

1 critical hiring needs as a result of the COVID–19  
2 pandemic or that have unfilled noncompetitive posi-  
3 tions shall establish a process by which staff with  
4 hiring authority receive the information described in  
5 paragraph (1) from the Office of Personnel Manage-  
6 ment about the expedited process for hiring such in-  
7 dividuals who meet the minimum qualifications of a  
8 vacant position.

9 (b) CORPORATION FOR NATIONAL AND COMMUNITY  
10 SERVICE.—The Chief Executive Officer of the Corpora-  
11 tion for National and Community Service, in coordination  
12 with the Director of the Peace Corps, shall establish an  
13 expedited process by which Peace Corps volunteers and  
14 trainees evacuated due to the COVID–19 public health  
15 emergency can participate in domestic service opportuni-  
16 ties through AmeriCorps, FEMA Corps, or affiliated pro-  
17 grams to help address the COVID–19 pandemic.

18 (c) FOREIGN SERVICE.—Section 301(c) of the For-  
19 eign Service Act of 1980 (22 U.S.C. 3941(c)) is amended  
20 to read as follows:

21 “(c)(1) The fact that an applicant for appointment  
22 as a Foreign Service officer candidate is a veteran or dis-  
23 abled veteran shall be considered an affirmative factor in  
24 making such appointments.

1       “(2) The fact that an applicant for appointment as  
2 a Foreign Service officer candidate is a returned Peace  
3 Corps volunteer shall be considered an affirmative factor  
4 in making such appointments. The value accorded the af-  
5 firmative factor under this paragraph shall be significant,  
6 but shall be less than the affirmative factor provided to  
7 individuals who qualify under paragraph (1).

8       “(3) In this subsection:

9           “(A) The term ‘returned Peace Corps volunteer’  
10 means an individual who has completed—

11           “(i) a full term of service as a volunteer  
12 under the Peace Corps Act (22 U.S.C. 2501 et  
13 seq.); or

14           “(ii) satisfactory service as a Peace Corps  
15 volunteer (as defined by the Director of the  
16 Peace Corps).

17           “(B) The term ‘veteran or disabled veteran’  
18 means an individual who is preference eligible (as  
19 defined in subparagraph (A), (B), or (C) of section  
20 2108(3) of title 5, United States Code).”.

21 **SEC. 4. RESUMPTION OF PEACE CORPS OPERATIONS.**

22       (a) IN GENERAL.—As soon as practicable after the  
23 Director of the Peace Corps determines, as a result of the  
24 cessation of the COVID–19 pandemic, that it is safe to  
25 resume Peace Corps global operations, the Director shall

1 seek to resume, to the fullest extent possible, all of its pro-  
2 grams in every country in which it operated immediately  
3 before the March 15, 2020, suspensions of all Peace Corps  
4 volunteer activities.

5 (b) REPORT ON RESTART OF PEACE CORPS OPER-  
6 ATIONS FOLLOWING END OF PUBLIC HEALTH EMER-  
7 GENCY.—Not later than 90 days after the date of enact-  
8 ment of this Act, the Director of the Peace Corps shall  
9 submit a report to the Committee on Foreign Relations  
10 of the Senate and the Committee on Foreign Affairs of  
11 the House of Representatives that describes the efforts of  
12 the Peace Corps to—

13 (1) offer reenrollment to each Peace Corps vol-  
14 unteer and trainee whose service ended suddenly on  
15 March 15, 2020 (or earlier, in the case of volunteers  
16 who were serving China and Mongolia), due to the  
17 COVID–19 public health emergency;

18 (2) obtain approval from countries, as appro-  
19 priate, to return reenrolled volunteers and trainees  
20 to their previous assignments or countries of service;

21 (3) provide additional measures necessary for  
22 the safety and health of volunteers and trainees and  
23 develop contingency plans in the event overseas oper-  
24 ations are disrupted by future COVID–19 outbreaks;

1                             (4) develop and maintain a robust volunteer co-  
2                             hort; and

3                             (5) identify the anticipated additional appro-  
4                             priations or new statutory authorities that would be  
5                             necessary to achieve the goal of safely redeploying  
6                             7,300 Peace Corps volunteers during the 1-year pe-  
7                             riod beginning on the date on which Peace Corps op-  
8                             erations resume.

9                             (c) EXPEDITED REENROLLMENT PROCESS.—The Di-  
10                             rector of the Peace Corps shall establish an expedited  
11                             process for the reenrollment of former Peace Corps volun-  
12                             teers and trainees whose service was interrupted as a re-  
13                             sult of the COVID–19 pandemic, including—

14                             (1) streamlining, to the fullest extent prac-  
15                             ticable, all application requirements for the reenroll-  
16                             ment of such volunteers and trainees during the 2-  
17                             year period beginning on March 15, 2020;

18                             (2) expediting the medical clearance for such  
19                             volunteers and trainees to facilitate reenrollment;

20                             (3) starting on the date on which such a volun-  
21                             teer or trainee reenrolls, providing such volunteer  
22                             and trainee with the compensation, allowances, bene-  
23                             fits, and other terms and conditions of service to  
24                             which such volunteer or trainee is entitled under the  
25                             Peace Corps Act (22 U.S.C. 2501 et seq.); and

8       (d) REENROLL DEFINED.—In this section, the term  
9 “reenroll” means a Peace Corps volunteer or trainee that  
10 was evacuated due to the COVID–19 public health emer-  
11 gency resuming service in the Peace Corps for a length  
12 of time determined by the Director of the Peace Corps.

**13 SEC. 5. USE OF OFFICIAL SEAL, EMBLEM, AND NAME OF  
14 THE PEACE CORPS.**

15 Section 19(b) of the Peace Corps Act (22 U.S.C.  
16 2518(b)) is amended—

1                   (2) in paragraph (2), by inserting “or in ac-  
2                   cordance with the exception specified in paragraph  
3                   (1),” after “under this chapter.”.

4 **SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

5                   There is authorized to be appropriated to carry out  
6 this Act and section 5(e)(2) of the Peace Corps Act, as  
7 added by section 2, such sums as may be necessary for  
8 each of the fiscal years 2020 through 2022.
