## RESOLUTION

Providing for consideration of the concurrent resolution (H. Con. Res. 24) expressing the sense of Congress that the report of Special Counsel Mueller should be made available to the public and to Congress, and providing for proceedings during the period from March 15, 2019, through March 22, 2019.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the concurrent  
3 resolution (H. Con. Res. 24) expressing the sense of Con-

1 gress that the report of Special Counsel Mueller should  
2 be made available to the public and to Congress. All points  
3 of order against consideration of the concurrent resolution  
4 are waived. The amendments to the concurrent resolution  
5 and the preamble printed in the report of the Committee  
6 on Rules accompanying this resolution shall be considered  
7 as adopted. The concurrent resolution, as amended, shall  
8 be considered as read. All points of order against provi-  
9 sions in the concurrent resolution, as amended, are  
10 waived. The previous question shall be considered as or-  
11 dered on the concurrent resolution and preamble, as  
12 amended, to adoption without intervening motion or de-  
13 mand for division of the question except one hour of de-  
14 bate equally divided and controlled by the chair and rank-  
15 ing minority member of the Committee on the Judiciary.

16 SEC. 2. On any legislative day during the period from  
17 March 15, 2019, through March 22, 2019—

18 (a) the Journal of the proceedings of the previous day  
19 shall be considered as approved; and

20 (b) the Chair may at any time declare the House ad-  
21 journed to meet at a date and time, within the limits of  
22 clause 4, section 5, article I of the Constitution, to be an-  
23 nounced by the Chair in declaring the adjournment.

24 SEC. 3. The Speaker may appoint Members to per-  
25 form the duties of the Chair for the duration of the period

- 1 addressed by section 2 of this resolution as though under
- 2 clause 8(a) of rule I.
