## RESOLUTION

Providing for consideration of the bill (H.R. 7) to amend the Fair Labor Standards Act of 1938 to provide more effective remedies to victims of discrimination in the payment of wages on the basis of sex, and for other purposes, and providing for consideration of the resolution (H. Res. 124) expressing opposition to banning service in the Armed Forces by openly transgender individuals.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 7) to amend the Fair Labor Stand-  
6 ards Act of 1938 to provide more effective remedies to  
7 victims of discrimination in the payment of wages on the  
8 basis of sex, and for other purposes. The first reading of  
9 the bill shall be dispensed with. All points of order against  
10 consideration of the bill are waived. General debate shall  
11 be confined to the bill and shall not exceed one hour equal-  
12 ly divided and controlled by the chair and ranking minor-  
13 ity member of the Committee on Education and Labor.  
14 After general debate the bill shall be considered for  
15 amendment under the five-minute rule. In lieu of the  
16 amendment in the nature of a substitute recommended by  
17 the Committee on Education and Labor now printed in  
18 the bill, it shall be in order to consider as an original bill  
19 for the purpose of amendment under the five-minute rule  
20 an amendment in the nature of a substitute consisting of  
21 the text of Rules Committee Print 116-8 modified by the  
22 amendment printed in part A of the report of the Com-  
23 mittee on Rules accompanying this resolution. That  
24 amendment in the nature of a substitute shall be consid-  
25 ered as read. All points of order against that amendment

1 in the nature of a substitute are waived. No amendment  
2 to that amendment in the nature of a substitute shall be  
3 in order except those printed in part B of the report of  
4 the Committee on Rules. Each such amendment may be  
5 offered only in the order printed in the report, may be  
6 offered only by a Member designated in the report, shall  
7 be considered as read, shall be debatable for the time spec-  
8 ified in the report equally divided and controlled by the  
9 proponent and an opponent, shall not be subject to amend-  
10 ment, and shall not be subject to a demand for division  
11 of the question in the House or in the Committee of the  
12 Whole. All points of order against such amendments are  
13 waived. At the conclusion of consideration of the bill for  
14 amendment the Committee shall rise and report the bill  
15 to the House with such amendments as may have been  
16 adopted. Any Member may demand a separate vote in the  
17 House on any amendment adopted in the Committee of  
18 the Whole to the bill or to the amendment in the nature  
19 of a substitute made in order as original text. The previous  
20 question shall be considered as ordered on the bill and  
21 amendments thereto to final passage without intervening  
22 motion except one motion to recommit with or without in-  
23 structions.

24       SEC. 2. Upon adoption of this resolution it shall be  
25 in order without intervention of any point of order to con-

1 sider in the House the resolution (H. Res. 124) expressing  
2 opposition to banning service in the Armed Forces by  
3 openly transgender individuals. The resolution shall be  
4 considered as read. The previous question shall be consid-  
5 ered as ordered on the resolution and preamble to adop-  
6 tion without intervening motion or demand for division of  
7 the question except one hour of debate equally divided and  
8 controlled by the chair and ranking minority member of  
9 the Committee on Armed Services.
