Providing for consideration of the bill (H.R. 2740) making appropriations for the Departments of Labor, Health and Human Services, and Education, and related agencies for the fiscal year ending September 30, 2020, and for other purposes, and providing for consideration of the resolution (H. Res. 430) authorizing the Committee on the Judiciary to initiate or intervene in judicial proceedings to enforce certain subpoenas and for other purposes.

Mr. RASKIN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2740) making appropriations for the Departments of Labor, Health and Human Services, and Education, and related agencies for the fiscal year ending September 30, 2020, and for other purposes, and providing for consideration of the resolution (H. Res. 430) authorizing the Committee on the Judiciary to initiate or intervene in judicial proceedings to enforce certain subpoenas and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2740) making appropriations for
6 the Departments of Labor, Health and Human Services,
7 and Education, and related agencies for the fiscal year
8 ending September 30, 2020, and for other purposes. The
9 first reading of the bill shall be dispensed with. All points
10 of order against consideration of the bill are waived. Gen-
11 eral debate shall be confined to the bill and shall not ex-
12 ceed one hour equally divided and controlled by the chair
13 and ranking minority member of the Committee on Appro-
14 priations. After general debate the bill shall be considered
15 for amendment under the five-minute rule. An amendment
16 in the nature of a substitute consisting of the text of Rules
17 Committee Print 116-17, modified by the amendment
18 printed in part A of the report of the Committee on Rules
19 accompanying this resolution, shall be considered as
20 adopted in the House and in the Committee of the Whole.
21 The bill, as amended, shall be considered as the original
22 bill for the purpose of further amendment under the five-
23 minute rule and shall be considered as read. Points of
24 order against provisions in the bill, as amended, for failure
25 to comply with clause 2 of rule XXI are waived.

1 SEC. 2. (a) No further amendment to the bill, as
2 amended, shall be in order except those printed in part
3 B of the report of the Committee on Rules accompanying
4 this resolution, amendments en bloc described in section
5 3 of this resolution, and pro forma amendments described
6 in section 4 of this resolution.

7 (b) Each further amendment printed in part B of the
8 report of the Committee on Rules shall be considered only
9 in the order printed in the report, may be offered only
10 by a Member designated in the report, shall be considered
11 as read, shall be debatable for the time specified in the
12 report equally divided and controlled by the proponent and
13 an opponent, may be withdrawn by the proponent at any
14 time before action thereon, shall not be subject to amend-
15 ment except as provided by section 4 of this resolution,
16 and shall not be subject to a demand for division of the
17 question in the House or in the Committee of the Whole.

18 (c) All points of order against further amendments
19 printed in part B of the report of the Committee on Rules
20 or against amendments en bloc described in section 3 of
21 this resolution are waived.

22 SEC. 3. It shall be in order at any time for the chair
23 of the Committee on Appropriations or her designee to
24 offer amendments en bloc consisting of further amend-
25 ments printed in part B of the report of the Committee

1 on Rules accompanying this resolution not earlier disposed
2 of. Amendments en bloc offered pursuant to this section
3 shall be considered as read, shall be debatable for 20 min-
4 utes equally divided and controlled by the chair and rank-
5 ing minority member of the Committee on Appropriations
6 or their respective designees, shall not be subject to
7 amendment except as provided by section 4 of this resolu-
8 tion, and shall not be subject to a demand for division
9 of the question in the House or in the Committee of the
10 Whole.

11 SEC. 4. During consideration of the bill for amend-
12 ment, the chair and ranking minority member of the Com-
13 mittee on Appropriations or their respective designees may
14 offer up to 15 pro forma amendments each at any point
15 for the purpose of debate.

16 SEC. 5. At the conclusion of consideration of the bill
17 for amendment pursuant to this resolution, the Committee
18 of the Whole shall rise without motion. No further consid-
19 eration of the bill shall be in order except pursuant to a
20 subsequent order of the House.

21 SEC. 6. (a) During consideration of H.R. 2740, it
22 shall not be in order to consider an amendment proposing
23 both a decrease in an appropriation designated pursuant
24 to section 251(b)(2)(A)(ii) of the Balanced Budget and

1 Emergency Deficit Control Act of 1985 and an increase
2 in an appropriation not so designated, or vice versa.

3 (b) This section shall not apply to an amendment be-
4 tween the Houses.

5 SEC. 7. Upon adoption of this resolution it shall be
6 in order without intervention of any point of order to con-
7 sider in the House the resolution (H. Res. 430) author-
8 izing the Committee on the Judiciary to initiate or inter-
9 vene in judicial proceedings to enforce certain subpoenas
10 and for other purposes. The amendment in the nature of
11 a substitute recommended by the Committee on Rules now
12 printed in the resolution shall be considered as adopted.
13 The resolution, as amended, shall be considered as read.
14 The previous question shall be considered as ordered on
15 the resolution, as amended, to adoption without inter-
16 vening motion or demand for division of the question ex-
17 cept one hour of debate equally divided and controlled by
18 the chair and ranking minority member of the Committee
19 on Rules.
