## RESOLUTION

Providing for consideration of the bill (H.R. 3877) to amend the Balanced Budget and Emergency Deficit Control Act of 1985, to establish a congressional budget for fiscal years 2020 and 2021, to temporarily suspend the debt limit, and for other purposes; providing for consideration of the bill (H.R. 549) to designate Venezuela under section 244 of the Immigration and Nationality Act to

permit nationals of Venezuela to be eligible for temporary protected status under such section, and for other purposes; and waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 3877) to amend the Balanced Budget and Emergency  
4 Deficit Control Act of 1985, to establish a congressional  
5 budget for fiscal years 2020 and 2021, to temporarily sus-  
6 pend the debt limit, and for other purposes. All points of  
7 order against consideration of the bill are waived. The bill  
8 shall be considered as read. All points of order against  
9 provisions in the bill are waived. The previous question  
10 shall be considered as ordered on the bill and on any  
11 amendment thereto to final passage without intervening  
12 motion except: (1) one hour of debate equally divided and  
13 controlled by chair and ranking minority member of the  
14 Committee on the Budget; and (2) one motion to recom-  
15 mit.

16       SEC. 2. Upon adoption of this resolution it shall be  
17 in order to consider in the House the bill (H.R. 549) to  
18 designate Venezuela under section 244 of the Immigration  
19 and Nationality Act to permit nationals of Venezuela to  
20 be eligible for temporary protected status under such sec-  
21 tion, and for other purposes. All points of order against

1 consideration of the bill are waived. In lieu of the amend-  
2 ment in the nature of a substitute recommended by the  
3 Committee on the Judiciary now printed in the bill, an  
4 amendment in the nature of a substitute consisting of the  
5 text of Rules Committee Print 116-28 shall be considered  
6 as adopted. The bill, as amended, shall be considered as  
7 read. All points of order against provisions in the bill, as  
8 amended, are waived. The previous question shall be con-  
9 sidered as ordered on the bill, as amended, and on any  
10 further amendment thereto, to final passage without inter-  
11 vening motion except: (1) 30 minutes of debate equally  
12 divided and controlled by the chair and ranking minority  
13 member of the Committee on the Judiciary; and (2) one  
14 motion to recommit with or without instructions.

15       SEC. 3. The requirement of clause 6(a) of rule XIII  
16 for a two-thirds vote to consider a report from the Com-  
17 mittee on Rules on the same day it is presented to the  
18 House is waived with respect to any resolution reported  
19 through the legislative day of July 26, 2019.
