RESOLUTION

Providing for consideration of the bill (H.R. 205) to amend the Gulf of Mexico Energy Security Act of 2006 to permanently extend the moratorium on leasing in certain areas of the Gulf of Mexico; providing for consideration of the bill (H.R. 1146) to amend Public Law 115–97 (commonly known as the Tax Cuts and Jobs Act) to repeal the Arctic National Wildlife Refuge oil and

gas program, and for other purposes; and providing for consideration of the bill (H.R. 1941) to amend the Outer Continental Shelf Lands Act to prohibit the Secretary of the Interior including in any leasing program certain planning areas, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 205) to amend the Gulf of Mexico
6 Energy Security Act of 2006 to permanently extend the
7 moratorium on leasing in certain areas of the Gulf of Mex-
8 ico. The first reading of the bill shall be dispensed with.
9 All points of order against consideration of the bill are
10 waived. General debate shall be confined to the bill and
11 amendments specified in this section and shall not exceed
12 one hour equally divided and controlled by the chair and
13 ranking minority member of the Committee on Natural
14 Resources. After general debate the bill shall be considered
15 for amendment under the five-minute rule. An amendment
16 in the nature of a substitute consisting of the text of Rules
17 Committee Print 116–29, modified by the amendment
18 printed in part A of the report of the Committee on Rules
19 accompanying this resolution, shall be considered as
20 adopted in the House and in the Committee of the Whole.
21 The bill, as amended, shall be considered as the original

1 bill for the purpose of further amendment under the five-
2 minute rule and shall be considered as read. All points
3 of order against provisions in the bill, as amended, are
4 waived. No further amendment to the bill, as amended,
5 shall be in order except those printed in part B of the
6 report of the Committee on Rules. Each such further
7 amendment may be offered only in the order printed in
8 the report, may be offered only by a Member designated
9 in the report, shall be considered as read, shall be debat-
10 able for the time specified in the report equally divided
11 and controlled by the proponent and an opponent, shall
12 not be subject to amendment, and shall not be subject to
13 a demand for division of the question in the House or in
14 the Committee of the Whole. All points of order against
15 such further amendments are waived. At the conclusion
16 of consideration of the bill for amendment the Committee
17 shall rise and report the bill, as amended, to the House
18 with such further amendments as may have been adopted.
19 The previous question shall be considered as ordered on
20 the bill, as amended, and on any further amendment
21 thereto to final passage without intervening motion except
22 one motion to recommit with or without instructions.

23 SEC. 2. At any time after adoption of this resolution
24 the Speaker may, pursuant to clause 2(b) of rule XVIII,
25 declare the House resolved into the Committee of the

1 Whole House on the state of the Union for consideration
2 of the bill (H.R. 1146) to amend Public Law 115–97
3 (commonly known as the Tax Cuts and Jobs Act) to repeal
4 the Arctic National Wildlife Refuge oil and gas program,
5 and for other purposes. The first reading of the bill shall
6 be dispensed with. All points of order against consider-
7 ation of the bill are waived. General debate shall be con-
8 fined to the bill and amendments specified in this section
9 and shall not exceed one hour equally divided and con-
10 trolled by the chair and ranking minority member of the
11 Committee on Natural Resources. After general debate the
12 bill shall be considered for amendment under the five-
13 minute rule. In lieu of the amendment in the nature of
14 a substitute recommended by the Committee on Natural
15 Resources now printed in the bill, an amendment in the
16 nature of a substitute consisting of the text of Rules Com-
17 mittee Print 116–30, modified by the amendment printed
18 in part C of the report of the Committee on Rules accom-
19 panying this resolution, shall be considered as adopted in
20 the House and in the Committee of the Whole. The bill,
21 as amended, shall be considered as the original bill for
22 the purpose of further amendment under the five-minute
23 rule and shall be considered as read. All points of order
24 against provisions in the bill, as amended, are waived. No
25 further amendment to the bill, as amended, shall be in

1 order except those printed in part D of the report of the
2 Committee on Rules. Each such further amendment may
3 be offered only in the order printed in the report, may
4 be offered only by a Member designated in the report,
5 shall be considered as read, shall be debatable for the time
6 specified in the report equally divided and controlled by
7 the proponent and an opponent, shall not be subject to
8 amendment, and shall not be subject to a demand for divi-
9 sion of the question in the House or in the Committee
10 of the Whole. All points of order against such further
11 amendments are waived. At the conclusion of consider-
12 ation of the bill for amendment the Committee shall rise
13 and report the bill, as amended, to the House with such
14 further amendments as may have been adopted. The pre-
15 vious question shall be considered as ordered on the bill,
16 as amended, and on any further amendment thereto to
17 final passage without intervening motion except one mo-
18 tion to recommit with or without instructions.

19 SEC. 3. At any time after adoption of this resolution
20 the Speaker may, pursuant to clause 2(b) of rule XVIII,
21 declare the House resolved into the Committee of the
22 Whole House on the state of the Union for consideration
23 of the bill (H.R. 1941) to amend the Outer Continental
24 Shelf Lands Act to prohibit the Secretary of the Interior
25 including in any leasing program certain planning areas,

1 and for other purposes. The first reading of the bill shall
2 be dispensed with. All points of order against consider-
3 ation of the bill are waived. General debate shall be con-
4 fined to the bill and amendments specified in this section
5 and shall not exceed one hour equally divided and con-

20 in part F of the report of the Committee on Rules. Each
21 such further amendment may be offered only in the order
22 printed in the report, may be offered only by a Member
23 designated in the report, shall be considered as read, shall
24 be debatable for the time specified in the report equally
25 divided and controlled by the proponent and an opponent,

1 shall not be subject to amendment, and shall not be sub-
2 ject to a demand for division of the question in the House
3 or in the Committee of the Whole. All points of order
4 against such further amendments are waived. At the con-
