## RESOLUTION

Providing for consideration of the bill (H.R. 823) to provide for the designation of certain wilderness areas, recreation management areas, and conservation areas in the State of Colorado, and for other purposes; providing for consideration of the bill (H.R. 1373) to protect, for current and future generations, the watershed, ecosystem, and cultural heritage of the Grand Canyon region in the

State of Arizona, and for other purposes; providing for consideration of the bill (H.R. 2181) to provide for the withdrawal and protection of certain Federal land in the State of New Mexico; and providing for proceedings during the period from November 1, 2019, through November 11, 2019.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 823) to provide for the designation  
6 of certain wilderness areas, recreation management areas,  
7 and conservation areas in the State of Colorado, and for  
8 other purposes. The first reading of the bill shall be dis-  
9 pensed with. All points of order against consideration of  
10 the bill are waived. General debate shall be confined to  
11 the bill and amendments specified in this section and shall  
12 not exceed one hour equally divided and controlled by the  
13 chair and ranking minority member of the Committee on  
14 Natural Resources. After general debate the bill shall be  
15 considered for amendment under the five-minute rule. The  
16 amendment in the nature of a substitute recommended by  
17 the Committee on Natural Resources now printed in the  
18 bill, modified by the amendment printed in part A of the  
19 report of the Committee on Rules accompanying this reso-  
20 lution, shall be considered as adopted in the House and

1 in the Committee of the Whole. The bill, as amended, shall  
2 be considered as the original bill for the purpose of further  
3 amendment under the five-minute rule and shall be consid-  
4 ered as read. All points of order against provisions in the  
5 bill, as amended, are waived. No further amendment to  
6 the bill, as amended, shall be in order except those printed  
7 in part B of the report of the Committee on Rules. Each  
8 such further amendment may be offered only in the order  
9 printed in the report, may be offered only by a Member  
10 designated in the report, shall be considered as read, shall  
11 be debatable for the time specified in the report equally  
12 divided and controlled by the proponent and an opponent,  
13 shall not be subject to amendment, and shall not be sub-  
14 ject to a demand for division of the question in the House  
15 or in the Committee of the Whole. All points of order  
16 against such further amendments are waived. At the con-  
17 clusion of consideration of the bill for amendment the  
18 Committee shall rise and report the bill, as amended, to  
19 the House with such further amendments as may have  
20 been adopted. The previous question shall be considered  
21 as ordered on the bill, as amended, and on any further  
22 amendment thereto to final passage without intervening  
23 motion except one motion to recommit with or without in-  
24 structions.

1        SEC. 2. At any time after adoption of this resolution  
2 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
3 declare the House resolved into the Committee of the  
4 Whole House on the state of the Union for consideration  
5 of the bill (H.R. 1373) to protect, for current and future  
6 generations, the watershed, ecosystem, and cultural herit-  
7 age of the Grand Canyon region in the State of Arizona,  
8 and for other purposes. The first reading of the bill shall  
9 be dispensed with. All points of order against consider-  
10 ation of the bill are waived. General debate shall be con-  
11 fined to the bill and shall not exceed one hour equally di-  
12 vided and controlled by the chair and ranking minority  
13 member of the Committee on Natural Resources. After  
14 general debate the bill shall be considered for amendment  
15 under the five-minute rule. It shall be in order to consider  
16 as an original bill for the purpose of amendment under  
17 the five-minute rule the amendment in the nature of a sub-  
18 stitute recommended by the Committee on Natural Re-  
19 sources now printed in the bill. The committee amendment  
20 in the nature of a substitute shall be considered as read.  
21 All points of order against the committee amendment in  
22 the nature of a substitute are waived. No amendment to  
23 the committee amendment in the nature of a substitute  
24 shall be in order except those printed in part C of the  
25 report of the Committee on Rules accompanying this reso-

1 lution. Each such amendment may be offered only in the  
2 order printed in the report, may be offered only by a Mem-  
3 ber designated in the report, shall be considered as read,  
4 shall be debatable for the time specified in the report  
5 equally divided and controlled by the proponent and an  
6 opponent, shall not be subject to amendment, and shall  
7 not be subject to a demand for division of the question  
8 in the House or in the Committee of the Whole. All points  
9 of order against such amendments are waived. At the con-  
10 clusion of consideration of the bill for amendment the  
11 Committee shall rise and report the bill to the House with  
12 such amendments as may have been adopted. Any Member  
13 may demand a separate vote in the House on any amend-  
14 ment adopted in the Committee of the Whole to the bill  
15 or to the committee amendment in the nature of a sub-  
16 stitute. The previous question shall be considered as or-  
17 dered on the bill and amendments thereto to final passage  
18 without intervening motion except one motion to recommit  
19 with or without instructions.

20       SEC. 3. At any time after adoption of this resolution  
21 the Speaker may, pursuant to clause 2(b) of rule XVIII,  
22 declare the House resolved into the Committee of the  
23 Whole House on the state of the Union for consideration  
24 of the bill (H.R. 2181) to provide for the withdrawal and  
25 protection of certain Federal land in the State of New

1 Mexico. The first reading of the bill shall be dispensed  
2 with. All points of order against consideration of the bill  
3 are waived. General debate shall be confined to the bill  
4 and amendments specified in this section and shall not ex-  
5 ceed one hour equally divided and controlled by the chair  
6 and ranking minority member of the Committee on Nat-  
7 ural Resources. After general debate the bill shall be con-  
8 sidered for amendment under the five-minute rule. The  
9 amendment printed in part D of the report of the Com-  
10 mittee on Rules accompanying this resolution shall be con-  
11 sidered as adopted in the House and in the Committee  
12 of the Whole. The bill, as amended, shall be considered  
13 as read. All points of order against provisions in the bill,  
14 as amended, are waived. No further amendment to the bill,  
15 as amended, shall be in order except those printed in part  
16 E of the report of the Committee on Rules. Each such  
17 further amendment may be offered only in the order print-  
18 ed in the report, may be offered only by a Member des-  
19 igned in the report, shall be considered as read, shall  
20 be debatable for the time specified in the report equally  
21 divided and controlled by the proponent and an opponent,  
22 shall not be subject to amendment, and shall not be sub-  
23 ject to a demand for division of the question in the House  
24 or in the Committee of the Whole. All points of order  
25 against such further amendments are waived. At the con-

1 clusion of consideration of the bill for amendment the  
2 Committee shall rise and report the bill, as amended, to  
3 the House with such further amendments as may have  
4 been adopted. The previous question shall be considered  
5 as ordered on the bill, as amended, and on any further  
6 amendment thereto to final passage without intervening  
7 motion except one motion to recommit with or without in-  
8 structions.

9       SEC. 4. On any legislative day during the period from  
10 November 1, 2019, through November 11, 2019—

11       (a) the Journal of the proceedings of the previous day  
12 shall be considered as approved; and

13       (b) the Chair may at any time declare the House ad-  
14 journed to meet at a date and time, within the limits of  
15 clause 4, section 5, article I of the Constitution, to be an-  
16 nounced by the Chair in declaring the adjournment.

17       SEC. 5. The Speaker may appoint Members to per-  
18 form the duties of the Chair for the duration of the period  
19 addressed by section 4 of this resolution as though under  
20 clause 8(a) of rule I.

21       SEC. 6. Each day during the period addressed by sec-  
22 tion 4 of this resolution shall not constitute a calendar  
23 or legislative day for purposes of clause 7(c)(1) of rule  
24 XXII.

1        SEC. 7. Each day during the period addressed by sec-  
2        tion 4 of this resolution shall not constitute a legislative  
3        day for purposes of clause 7 of rule XV.
