Mr. RASKIN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 790) to provide for a pay increase in 2019 for certain civilian employees of the Federal Government, and for other purposes, and providing for consideration of motions to suspend the rules.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 790) to provide for a pay increase

1 in 2019 for certain civilian employees of the Federal Gov-
2 ernment, and for other purposes. The first reading of the
3 bill shall be dispensed with. All points of order against
4 consideration of the bill are waived. General debate shall
5 be confined to the bill and shall not exceed one hour equal-
6 ly divided and controlled by the chair and ranking minor-
7 ity member of the Committee on Oversight and Reform.
8 After general debate the bill shall be considered for
9 amendment under the five-minute rule. The amendment
10 printed in part A of the report of the Committee on Rules
11 accompanying this resolution shall be considered as adopt-
12 ed in the House and in the Committee of the Whole. The
13 bill, as amended, shall be considered as read. All points
14 of order against provisions in the bill, as amended, are
15 waived. No further amendment to the bill, as amended,
16 shall be in order except those printed in part B of the
17 report of the Committee on Rules. Each such further
18 amendment may be offered only in the order printed in
19 the report, may be offered only by a Member designated
20 in the report, shall be considered as read, shall be debat-
21 able for the time specified in the report equally divided
22 and controlled by the proponent and an opponent, shall
23 not be subject to amendment, and shall not be subject to
24 a demand for division of the question in the House or in
25 the Committee of the Whole. All points of order against

1 such further amendments are waived. At the conclusion
2 of consideration of the bill for amendment the Committee
3 shall rise and report the bill, as amended, to the House
4 with such further amendments as may have been adopted.
5 The previous question shall be considered as ordered on
6 the bill, as amended, and on any further amendment
7 thereto, to final passage without intervening motion except
8 one motion to recommit with or without instructions.

9 SEC. 2. It shall be in order at any time through the
10 legislative day of February 8, 2019, for the Speaker to
11 entertain motions that the House suspend the rules as
12 though under clause 1 of rule XV. The Speaker or her
13 designee shall consult with the Minority Leader or his des-
14 ignee on the designation of any matter for consideration
15 pursuant to this section.
