## A BILL

To provide for an increase, effective December 1, 2019, in the rates of compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for the survivors of certain disabled veterans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans’ Compensa-  
5 tion Cost-of-Living Adjustment Act of 2019”.

1 **SEC. 2. INCREASE IN RATES OF DISABILITY COMPENSA-**  
2 **TION AND DEPENDENCY AND INDEMNITY**  
3 **COMPENSATION.**

4 (a) **RATE ADJUSTMENT.**—Effective on December 1,  
5 2019, the Secretary of Veterans Affairs shall increase, in  
6 accordance with subsection (c), the dollar amounts in ef-  
7 fect on November 30, 2019, for the payment of disability  
8 compensation and dependency and indemnity compensa-  
9 tion under the provisions specified in subsection (b).

10 (b) **AMOUNTS TO BE INCREASED.**—The dollar  
11 amounts to be increased pursuant to subsection (a) are  
12 the following:

13 (1) **WARTIME DISABILITY COMPENSATION.**—  
14 Each of the dollar amounts under section 1114 of  
15 title 38, United States Code.

16 (2) **ADDITIONAL COMPENSATION FOR DEPEND-**  
17 **ENTS.**—Each of the dollar amounts under section  
18 1115(1) of such title.

19 (3) **CLOTHING ALLOWANCE.**—The dollar  
20 amount under section 1162 of such title.

21 (4) **DEPENDENCY AND INDEMNITY COMPENSA-**  
22 **TION TO SURVIVING SPOUSE.**—Each of the dollar  
23 amounts under subsections (a) through (d) of sec-  
24 tion 1311 of such title.

1           (5) DEPENDENCY AND INDEMNITY COMPENSA-  
2           TION TO CHILDREN.—Each of the dollar amounts  
3           under sections 1313(a) and 1314 of such title.

4           (c) DETERMINATION OF INCREASE.—Each dollar  
5           amount described in subsection (b) shall be increased by  
6           the same percentage as the percentage by which benefit  
7           amounts payable under title II of the Social Security Act  
8           (42 U.S.C. 401 et seq.) are increased effective December  
9           1, 2019, as a result of a determination under section  
10          215(i) of such Act (42 U.S.C. 415(i)).

11          (d) SPECIAL RULE.—The Secretary of Veterans Af-  
12          fairs may adjust administratively, consistent with the in-  
13          creases made under subsection (a), the rates of disability  
14          compensation payable to persons under section 10 of Pub-  
15          lic Law 85–857 (72 Stat. 1263) who have not received  
16          compensation under chapter 11 of title 38, United States  
17          Code.

18          (e) PUBLICATION OF ADJUSTED RATES.—The Sec-  
19          retary of Veterans Affairs shall publish in the Federal  
20          Register the amounts specified in subsection (b), as in-  
21          creased under subsection (a), not later than the date on  
22          which the matters specified in section 215(i)(2)(D) of the  
23          Social Security Act (42 U.S.C. 415(i)(2)(D)) are required

- 1 to be published by reason of a determination made under
- 2 section 215(i) of such Act during fiscal year 2020.
