## A BILL

To designate certain land administered by the Bureau of Land Management and the Forest Service in the State of Oregon as wilderness and national recreation areas and to make additional wild and scenic river designations in the State of Oregon, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) SHORT TITLE.—This Act may be cited as the  
5 “Oregon Wildlands Act”.

### 1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) SECRETARY.—The term “Secretary”  
4 means—

5 (A) the Secretary of the Interior, with re-  
6 spect to public land administered by the Sec-  
7 retary of the Interior; or

8 (B) the Secretary of Agriculture, with re-  
9 spect to National Forest System land.

10 (2) STATE.—The term “State” means the State  
11 of Oregon.

## 12 **TITLE I—RECREATION AREAS**

### 13 **SEC. 101. ROGUE CANYON AND MOLALLA RECREATION** 14 **AREAS, OREGON.**

15 (a) DESIGNATION OF ROGUE CANYON AND MOLALLA  
16 RECREATION AREAS.—For the purposes of protecting,

1 conserving, and enhancing the unique and nationally im-  
2 portant recreational, ecological, scenic, cultural, water-  
3 shed, and fish and wildlife values of the areas, the fol-  
4 lowing areas in the State are designated as recreation  
5 areas for management by the Secretary in accordance with  
6 subsection (c):

7           (1) ROGUE CANYON RECREATION AREA.—The  
8           approximately 98,150 acres of Bureau of Land Man-  
9           agement land within the boundary generally depicted  
10          as the “Rogue Canyon Recreation Area” on the map  
11          entitled “Rogue Canyon Recreation Area Wild  
12          Rogue Wilderness Additions” and dated October 10,  
13          2018, which is designated as the “Rogue Canyon  
14          Recreation Area”.

15          (2) MOLALLA RECREATION AREA.—The ap-  
16          proximately 29,884 acres of Bureau of Land Man-  
17          agement land within the boundary generally depicted  
18          on the map entitled “Molalla Recreation Area” and  
19          dated September 26, 2018, which is designated as  
20          the “Molalla Recreation Area”.

21          (b) MAPS AND LEGAL DESCRIPTIONS.—

22                 (1) IN GENERAL.—As soon as practicable after  
23                 the date of enactment of this Act, the Secretary  
24                 shall a prepare a map and legal description of each  
25                 recreation area designated by subsection (a).

1           (2) EFFECT.—The maps and legal descriptions  
2 prepared under paragraph (1) shall have the same  
3 force and effect as if included in this Act, except  
4 that the Secretary may correct any minor errors in  
5 the maps and legal descriptions.

6           (3) PUBLIC AVAILABILITY.—The maps and  
7 legal descriptions prepared under paragraph (1)  
8 shall be available for public inspection in the appro-  
9 priate offices of the Bureau of Land Management.

10 (c) ADMINISTRATION.—

11           (1) APPLICABLE LAW.—The Secretary shall ad-  
12 minister each recreation area designated by sub-  
13 section (a)—

14                   (A) in a manner that conserves, protects,  
15 and enhances the purposes for which the recre-  
16 ation area is established; and

17                   (B) in accordance with—

18                           (i) this section;

19                           (ii) the Federal Land Policy and Man-  
20 agement Act of 1976 (43 U.S.C. 1701 et  
21 seq.); and

22                           (iii) other applicable laws.

23           (2) USES.—The Secretary shall only allow those  
24 uses of a recreation area designated by subsection

1 (a) that are consistent with the purposes for which  
2 the recreation area is established.

3 (3) ROAD CONSTRUCTION.—

4 (A) IN GENERAL.—Except as the Sec-  
5 retary determines necessary for public safety,  
6 no new permanent or temporary roads shall be  
7 constructed (other than the repair and mainte-  
8 nance of existing roads) within a recreation  
9 area designated by subsection (a).

10 (B) EFFECT.—Nothing in this paragraph  
11 affects the administration by the Secretary of  
12 the Molalla Forest Road in accordance with ap-  
13 plicable resource management plans.

14 (4) VEGETATION MANAGEMENT.—Nothing in  
15 this section prohibits the Secretary from conducting  
16 vegetation management projects within a recreation  
17 area designated by subsection (a) to the extent con-  
18 sistent with the purposes of the recreation area.

19 (5) WITHDRAWAL.—Subject to valid existing  
20 rights, all Federal surface and subsurface land with-  
21 in a recreation area designated by subsection (a) is  
22 withdrawn from all forms of—

23 (A) entry, appropriation, or disposal under  
24 the public land laws;

1 (B) location, entry, and patent under the  
2 mining laws; and

3 (C) laws pertaining to mineral and geo-  
4 thermal leasing and mineral materials.

5 (d) ADJACENT MANAGEMENT.—Nothing in this sec-  
6 tion creates any protective perimeter or buffer zone  
7 around a recreation area designated by subsection (a).

8 **TITLE II—ADDITIONAL WILD**  
9 **AND SCENIC RIVER DESIGNA-**  
10 **TIONS AND TECHNICAL COR-**  
11 **RECTIONS**

12 **SEC. 201. ADDITIONS TO ROGUE WILD AND SCENIC RIVER.**

13 (a) IN GENERAL.—Section 3(a) of the Wild and Sce-  
14 nic Rivers Act (16 U.S.C. 1274(a)) is amended by striking  
15 paragraph (5) and inserting the following:

16 “(5) ROGUE, OREGON.—

17 “(A) IN GENERAL.—The segment of the  
18 river extending from the mouth of the Apple-  
19 gate River downstream to the Lobster Creek  
20 Bridge, to be administered by the Secretary of  
21 the Interior or the Secretary of Agriculture, as  
22 agreed to by the Secretaries of the Interior and  
23 Agriculture or as directed by the President.

24 “(B) ADDITIONS.—In addition to the seg-  
25 ment described in subparagraph (A), there are

1 designated the following segments in the Rogue  
2 River:

3 “(i) KELSEY CREEK.—The approxi-  
4 mately 6.8-mile segment of Kelsey Creek  
5 from the Wild Rogue Wilderness boundary  
6 in T. 32 S., R. 9 W., sec. 25, Willamette  
7 Meridian, to the confluence with the Rogue  
8 River, as a wild river.

9 “(ii) EAST FORK KELSEY CREEK.—

10 “(I) SCENIC RIVER.—The ap-  
11 proximately 0.2-mile segment of East  
12 Fork Kelsey Creek from headwaters  
13 downstream to the Wild Rogue Wil-  
14 derness boundary in T. 33 S., R. 8  
15 W., sec. 5, Willamette Meridian, as a  
16 scenic river.

17 “(II) WILD RIVER.—The ap-  
18 proximately 4.6-mile segment of East  
19 Fork Kelsey Creek from the Wild  
20 Rogue Wilderness boundary in T. 33  
21 S., R. 8 W., sec. 5, Willamette Merid-  
22 ian, to the confluence with Kelsey  
23 Creek, as a wild river.

24 “(iii) WHISKY CREEK.—

## 1                   “(I) RECREATIONAL RIVER.—

2                   The approximately 1.6-mile segment  
 3                   of Whisky Creek from the confluence  
 4                   of the East Fork and West Fork to  
 5                   the south boundary of the non-Fed-  
 6                   eral land in T. 33 S., R. 8 W., sec.  
 7                   17, Willamette Meridian, as a rec-  
 8                   reational river.

9                   “(II) WILD RIVER.—The ap-  
 10                  proximately 1.2-mile segment of Whis-  
 11                  ky Creek from road 33-8-23 to the  
 12                  confluence with the Rogue River, as a  
 13                  wild river.

## 14                  “(iv) EAST FORK WHISKY CREEK.—

15                  “(I) SCENIC RIVER.—The ap-  
 16                  proximately 0.9-mile segment of East  
 17                  Fork Whisky Creek from its head-  
 18                  waters to Wild Rogue Wilderness  
 19                  boundary in T. 33 S., R. 8 W., sec.  
 20                  11, Willamette Meridian, as a scenic  
 21                  river.

22                  “(II) WILD RIVER.—The ap-  
 23                  proximately 2.6-mile segment of East  
 24                  Fork Whisky Creek from the Wild  
 25                  Rogue Wilderness boundary in T. 33



1 S., R. 8 W., sec. 11, Willamette Me-  
 2 ridian, downstream to road 33-8-26  
 3 crossing, as a wild river.

4 “(III) RECREATIONAL RIVER.—  
 5 The approximately 0.3-mile segment  
 6 of East Fork Whisky Creek from road  
 7 33-8-26 to the confluence with Whis-  
 8 ky Creek, as a recreational river.

9 “(v) WEST FORK WHISKY CREEK.—  
 10 The approximately 4.8-mile segment of  
 11 West Fork Whisky Creek from its head-  
 12 waters to the confluence with the East  
 13 Fork Whisky Creek, as a wild river.

14 “(vi) BIG WINDY CREEK.—

15 “(I) SCENIC RIVER.—The ap-  
 16 proximately 1.5-mile segment of Big  
 17 Windy Creek from its headwaters to  
 18 road 34-9-17.1, as a scenic river.

19 “(II) WILD RIVER.—The ap-  
 20 proximately 5.8-mile segment of Big  
 21 Windy Creek from road 34-9-17.1 to  
 22 the confluence with the Rogue River,  
 23 as a wild river.

24 “(vii) EAST FORK BIG WINDY  
 25 CREEK.—

1                   “(I) SCENIC RIVER.—The ap-  
 2                   proximately 0.2-mile segment of East  
 3                   Fork Big Windy Creek from its head-  
 4                   waters to road 34-8-36, as a scenic  
 5                   river.

6                   “(II) WILD RIVER.—The ap-  
 7                   proximately 3.7-mile segment of East  
 8                   Fork Big Windy Creek from road 34-  
 9                   8-36 to the confluence with Big  
 10                  Windy Creek, as a wild river.

11                  “(viii) LITTLE WINDY CREEK.—

12                   “(I) SCENIC RIVER.—The ap-  
 13                   proximately 1.2-mile segment of Little  
 14                   Windy Creek from its headwaters to  
 15                   the Wild Rogue Wilderness boundary  
 16                   in T. 33 S., R. 9 W., sec. 33, Willam-  
 17                   ette Meridian, as a scenic river.

18                   “(II) WILD RIVER.—The ap-  
 19                   proximately 1.9-mile segment of Little  
 20                   Windy Creek from the Wild Rogue  
 21                   Wilderness boundary in T. 33 S., R.  
 22                   9 W., sec. 34, Willamette Meridian, to  
 23                   the confluence with the Rogue River,  
 24                   as a wild river.

25                  “(ix) HOWARD CREEK.—

1           “(I) SCENIC RIVER.—The ap-  
 2           proximately 3.5-mile segment of How-  
 3           ard Creek from its headwaters to road  
 4           34-9-34, as a scenic river.

5           “(II) WILD RIVER.—The ap-  
 6           proximately 6.9-mile segment of How-  
 7           ard Creek from 0.1 miles downstream  
 8           of road 34-9-34 to the confluence with  
 9           the Rogue River, as a wild river.

10          “(III) WILD RIVER.—The ap-  
 11          proximately 3.5-mile segment of Anna  
 12          Creek from its headwaters to the con-  
 13          fluence with Howard Creek, as a wild  
 14          river.

15          “(x) MULE CREEK.—

16          “(I) SCENIC RIVER.—The ap-  
 17          proximately 3.5-mile segment of Mule  
 18          Creek from its headwaters down-  
 19          stream to the Wild Rogue Wilderness  
 20          boundary as a scenic river.

21          “(II) WILD RIVER.—The ap-  
 22          proximately 7.8-mile segment of Mule  
 23          Creek from the Wild Rogue Wilder-  
 24          ness boundary in T. 32 S., R. 9 W.,  
 25          sec. 29, Willamette Meridian, to the

1 confluence with the Rogue River, as a  
2 wild river.

3 “(xi) MISSOURI CREEK.—

4 “(I) SCENIC RIVER.—The ap-  
5 proximately 3.1-mile segment of Mis-  
6 souri Creek from its headwaters  
7 downstream to the Wild Rogue Wil-  
8 derness boundary in T. 33 S., R. 10  
9 W., sec. 24, Willamette Meridian, as a  
10 scenic river.

11 “(II) WILD RIVER.—The ap-  
12 proximately 1.6-mile segment of Mis-  
13 souri Creek from the Wild Rogue Wil-  
14 derness boundary in T. 33 S., R. 10  
15 W., sec. 24, Willamette Meridian, to  
16 the confluence with the Rogue River,  
17 as a wild river.

18 “(xii) JENNY CREEK.—

19 “(I) SCENIC RIVER.—The ap-  
20 proximately 3.1-mile segment of  
21 Jenny Creek from its headwaters  
22 downstream to the Wild Rogue Wil-  
23 derness boundary in T. 33 S., R. 9  
24 W., sec. 28, Willamette Meridian, as a  
25 scenic river.

1                   “(II) WILD RIVER.—The ap-  
 2                   proximately 1.8-mile segment of  
 3                   Jenny Creek from the Wild Rogue  
 4                   Wilderness boundary in T. 33 S., R.  
 5                   9 W., sec. 28, Willamette Meridian, to  
 6                   the confluence with the Rogue River,  
 7                   as a wild river.

8                   “(xiii) RUM CREEK.—

9                   “(I) SCENIC RIVER.—The ap-  
 10                   proximately 2.2-mile segment of Rum  
 11                   Creek from its headwaters to the Wild  
 12                   Rogue Wilderness boundary in T. 34  
 13                   S., R. 8 W., sec. 9, Willamette Merid-  
 14                   ian, as a scenic river.

15                   “(II) WILD RIVER.—The ap-  
 16                   proximately 2.2-mile segment of Rum  
 17                   Creek from the Wild Rogue Wilder-  
 18                   ness boundary in T. 34 S., R. 8 W.,  
 19                   sec. 9, Willamette Meridian, to the  
 20                   confluence with the Rogue River, as a  
 21                   wild river.

22                   “(xiv) EAST FORK RUM CREEK.—

23                   “(I) SCENIC RIVER.—The ap-  
 24                   proximately 0.8-mile segment of East  
 25                   Fork Rum Creek from its headwaters

1 to the Wild Rogue Wilderness bound-  
 2 ary in T. 34 S., R. 8 W., sec. 10, Wil-  
 3 lamette Meridian, as a scenic river.

4 “(II) WILD RIVER.—The ap-  
 5 proximately 1.3-mile segment of East  
 6 Fork Rum Creek from the Wild  
 7 Rogue Wilderness boundary in T. 34  
 8 S., R. 8 W., sec. 10, Willamette Me-  
 9 ridian, to the confluence with Rum  
 10 Creek, as a wild river.

11 “(xv) WILDCAT CREEK.—The approxi-  
 12 mately 1.7-mile segment of Wildeat Creek  
 13 from its headwaters downstream to the  
 14 confluence with the Rogue River, as a wild  
 15 river.

16 “(xvi) MONTGOMERY CREEK.—The  
 17 approximately 1.8-mile segment of Mont-  
 18 gomery Creek from its headwaters down-  
 19 stream to the confluence with the Rogue  
 20 River, as a wild river.

21 “(xvii) HEWITT CREEK.—

22 “(I) SCENIC RIVER.—The ap-  
 23 proximately 1.4-mile segment of Hew-  
 24 itt Creek from its headwaters to the  
 25 Wild Rogue Wilderness boundary in

1 T. 33 S., R. 9 W., sec. 19, Willamette  
2 Meridian, as a scenic river.

3 “(II) WILD RIVER.—The ap-  
4 proximately 1.2-mile segment of Hew-  
5 itt Creek from the Wild Rogue Wil-  
6 derness boundary in T. 33 S., R. 9  
7 W., sec. 19, Willamette Meridian, to  
8 the confluence with the Rogue River,  
9 as a wild river.

10 “(xviii) BUNKER CREEK.—The ap-  
11 proximately 6.6-mile segment of Bunker  
12 Creek from its headwaters to the con-  
13 fluence with the Rogue River, as a wild  
14 river.

15 “(xix) DULOG CREEK.—

16 “(I) SCENIC RIVER.—The ap-  
17 proximately 0.8-mile segment of  
18 Dulog Creek from its headwaters to  
19 0.1 miles downstream of road 34-8-  
20 36, as a scenic river.

21 “(II) WILD RIVER.—The ap-  
22 proximately 1.0-mile segment of  
23 Dulog Creek from road 34-8-36 to the  
24 confluence with the Rogue River, as a  
25 wild river.

1           “(xx) QUAIL CREEK.—The approxi-  
2           mately 1.7-mile segment of Quail Creek  
3           from the Wild Rogue Wilderness boundary  
4           in T. 33 S., R. 10 W., sec. 1, Willamette  
5           Meridian, to the confluence with the Rogue  
6           River, as a wild river.

7           “(xxi) MEADOW CREEK.—The ap-  
8           proximately 4.1-mile segment of Meadow  
9           Creek from its headwaters to the con-  
10          fluence with the Rogue River, as a wild  
11          river.

12          “(xxii) RUSSIAN CREEK.—The ap-  
13          proximately 2.5-mile segment of Russian  
14          Creek from the Wild Rogue Wilderness  
15          boundary in T. 33 S., R. 8 W., sec. 20,  
16          Willamette Meridian, to the confluence  
17          with the Rogue River, as a wild river.

18          “(xxiii) ALDER CREEK.—The approxi-  
19          mately 1.2-mile segment of Alder Creek  
20          from its headwaters to the confluence with  
21          the Rogue River, as a wild river.

22          “(xxiv) BOOZE CREEK.—The approxi-  
23          mately 1.5-mile segment of Booze Creek  
24          from its headwaters to the confluence with  
25          the Rogue River, as a wild river.



1           “(xxv) BRONCO CREEK.—The ap-  
2           proximately 1.8-mile segment of Bronco  
3           Creek from its headwaters to the con-  
4           fluence with the Rogue River, as a wild  
5           river.

6           “(xxvi) COPSEY CREEK.—The ap-  
7           proximately 1.5-mile segment of Copsey  
8           Creek from its headwaters to the con-  
9           fluence with the Rogue River, as a wild  
10          river.

11          “(xxvii) CORRAL CREEK.—The ap-  
12          proximately 0.5-mile segment of Corral  
13          Creek from its headwaters to the con-  
14          fluence with the Rogue River, as a wild  
15          river.

16          “(xxviii) COWLEY CREEK.—The ap-  
17          proximately 0.9-mile segment of Cowley  
18          Creek from its headwaters to the con-  
19          fluence with the Rogue River, as a wild  
20          river.

21          “(xxix) DITCH CREEK.—The approxi-  
22          mately 1.8-mile segment of Ditch Creek  
23          from the Wild Rogue Wilderness boundary  
24          in T. 33 S., R. 9 W., sec. 5, Willamette

1 Meridian, to its confluence with the Rogue  
2 River, as a wild river.

3 “(xxx) FRANCIS CREEK.—The ap-  
4 proximately 0.9-mile segment of Francis  
5 Creek from its headwaters to the con-  
6 fluence with the Rogue River, as a wild  
7 river.

8 “(xxxii) LONG GULCH.—

9 “(I) SCENIC RIVER.—The ap-  
10 proximately 1.4-mile segment of Long  
11 Gulch from its headwaters to the Wild  
12 Rogue Wilderness boundary in T. 33  
13 S., R. 10 W., sec. 23, Willamette Me-  
14 ridian, as a scenic river.

15 “(II) WILD RIVER.—The ap-  
16 proximately 1.1-mile segment of Long  
17 Gulch from the Wild Rogue Wilder-  
18 ness boundary in T. 33 S., R. 10 W.,  
19 sec. 23, Willamette Meridian, to the  
20 confluence with the Rogue River, as a  
21 wild river.

22 “(xxxii) BAILEY CREEK.—

23 “(I) SCENIC RIVER.—The ap-  
24 proximately 1.4-mile segment of Bai-  
25 ley Creek from its headwaters to the

1 Wild Rogue Wilderness boundary on  
 2 the west section line of T. 34 S., R.  
 3 8 W., sec. 14, Willamette Meridian, as  
 4 a scenic river.

5 “(II) WILD RIVER.—The ap-  
 6 proximately 1.7-mile segment of Bai-  
 7 ley Creek from the west section line of  
 8 T. 34 S., R.8 W., sec. 14, Willamette  
 9 Meridian, to the confluence of the  
 10 Rogue River, as a wild river.

11 “(xxxiii) SHADY CREEK.—The ap-  
 12 proximately 0.7-mile segment of Shady  
 13 Creek from its headwaters to the con-  
 14 fluence with the Rogue River, as a wild  
 15 river.

16 “(xxxiv) SLIDE CREEK.—

17 “(I) SCENIC RIVER.—The ap-  
 18 proximately 0.5-mile segment of Slide  
 19 Creek from its headwaters to road 33-  
 20 9-6, as a scenic river.

21 “(II) WILD RIVER.—The ap-  
 22 proximately 0.7-mile section of Slide  
 23 Creek from road 33-9-6 to the con-  
 24 fluence with the Rogue River, as a  
 25 wild river.”.

1 (b) MANAGEMENT.—Each river segment designated  
2 by subparagraph (B) of section 3(a)(5) of the Wild and  
3 Scenic Rivers Act (16 U.S.C. 1274(a)(5)) (as added by  
4 subsection (a)) shall be managed as part of the Rogue  
5 Wild and Scenic River.

6 (c) WITHDRAWAL.—Subject to valid existing rights,  
7 the Federal land within the boundaries of the river seg-  
8 ments designated by subparagraph (B) of section 3(a)(5)  
9 of the Wild and Scenic Rivers Act (16 U.S.C. 1274(a)(5))  
10 (as added by subsection (a)) is withdrawn from all forms  
11 of—

12 (1) entry, appropriation, or disposal under the  
13 public land laws;

14 (2) location, entry, and patent under the mining  
15 laws; and

16 (3) disposition under all laws pertaining to min-  
17 eral and geothermal leasing or mineral materials.

18 (d) ADDITIONAL PROTECTIONS FOR ROGUE RIVER  
19 TRIBUTARIES.—

20 (1) LICENSING BY COMMISSION.—The Federal  
21 Energy Regulatory Commission shall not license the  
22 construction of any dam, water conduit, reservoir,  
23 powerhouse, transmission line, or other project  
24 works on or directly affecting any stream described  
25 in paragraph (4).

1 (2) OTHER AGENCIES.—

2 (A) IN GENERAL.—No department or  
3 agency of the United States shall assist by loan,  
4 grant, license, or otherwise in the construction  
5 of any water resources project on or directly af-  
6 fecting any stream segment that is described in  
7 paragraph (4), except to maintain or repair  
8 water resources projects in existence on the  
9 date of enactment of this Act.

10 (B) EFFECT.—Nothing in this paragraph  
11 prohibits any department or agency of the  
12 United States in assisting by loan, grant, li-  
13 cense, or otherwise, a water resources project—

14 (i) the primary purpose of which is ec-  
15 ological or aquatic restoration;

16 (ii) that provides a net benefit to  
17 water quality and aquatic resources; and

18 (iii) that is consistent with protecting  
19 and enhancing the values for which the  
20 river was designated.

21 (3) WITHDRAWAL.—Subject to valid existing

## 4 **TITLE III—WILDERNESS AREAS**

### 5 **SEC. 301. EXPANSION OF WILD ROGUE WILDERNESS AREA.**

6 (a) DEFINITIONS.—In this section:

7 (1) MAP.—The term “map” means the map en-  
8 titled “Rogue Canyon Recreation Area Wild Rogue  
9 Wilderness Additions” and dated October 10, 2018.

10 (2) WILDERNESS ADDITIONS.—The term “Wil-  
11 derness additions” means the land added to the Wild  
12 Rogue Wilderness under subsection (b)(1).

13 (b) EXPANSION OF WILD ROGUE WILDERNESS  
14 AREA.—

15 (1) EXPANSION.—The approximately 59,512  
16 acres of Federal land in the State generally depicted  
17 on the map as “Proposed Wilderness” shall be  
18 added to and administered as part of the Wild  
19 Rogue Wilderness in accordance with the Endan-  
20 gered American Wilderness Act of 1978 (16 U.S.C.  
21 1132 note; Public Law 95–237), except that—

22 (A) the Secretary of the Interior and the  
23 Secretary of Agriculture shall administer the  
24 Federal land under their respective jurisdiction;  
25 and



1 (B) any reference in that Act to the Sec-  
2 retary of Agriculture shall be considered to be  
3 a reference to the Secretary of Agriculture or  
4 the Secretary of the Interior, as applicable.

5 (2) MAP; LEGAL DESCRIPTION.—

6 (A) IN GENERAL.—As soon as practicable  
7 after the date of enactment of this Act, the Sec-  
8 retary shall prepare a map and legal description  
9 of the wilderness area designated by paragraph  
10 (1).

11 (B) FORCE OF LAW.—The map and legal  
12 description filed under subparagraph (A) shall  
13 have the same force and effect as if included in  
14 this section, except that the Secretary may cor-  
15 rect typographical errors in the map and legal  
16 description.

17 (C) PUBLIC AVAILABILITY.—The map and  
18 legal description filed under subparagraph (A)  
19 shall be on file and available for public inspec-  
20 tion in the appropriate offices of the Bureau of  
21 Land Management and Forest Service.

22 (3) WITHDRAWAL.—Subject to valid existing  
23 rights, the Wilderness additions are withdrawn from  
24 all forms of—

1 (A) entry, appropriation, or disposal under  
2 the public land laws;

3 (B) location, entry, and patent under the  
4 mining laws; and

5 (C) disposition under all laws pertaining to  
6 mineral and geothermal leasing or mineral ma-  
7 terials.

8 (4) TRIBAL RIGHTS.—Nothing in this sub-  
9 section alters, modifies, enlarges, diminishes, or ab-  
10 rogates the treaty rights of any Indian tribe.

11 **SEC. 302. DEVIL’S STAIRCASE WILDERNESS.**

12 (a) DEFINITIONS.—In this section:

13 (1) MAP.—The term “map” means the map en-  
14 titled “Devil’s Staircase Wilderness Proposal” and  
15 dated July 26, 2018.

16 (2) WILDERNESS.—The term “Wilderness”  
17 means the Devil’s Staircase Wilderness designated  
18 by subsection (b).

19 (b) DESIGNATION.—In accordance with the Wilder-  
20 ness Act (16 U.S.C. 1131 et seq.), the approximately  
21 30,621 acres of Forest Service land and Bureau of Land  
22 Management land in the State, as generally depicted on  
23 the map, is designated as wilderness and as a component  
24 of the National Wilderness Preservation System, to be  
25 known as the “Devil’s Staircase Wilderness”.

1 (c) MAP; LEGAL DESCRIPTION.—

2 (1) IN GENERAL.—As soon as practicable after  
3 the date of enactment of this Act, the Secretary  
4 shall prepare a map and legal description of the Wil-  
5 derness.

6 (2) FORCE OF LAW.—The map and legal de-  
7 scription prepared under paragraph (1) shall have  
8 the same force and effect as if included in this Act,  
9 except that the Secretary may correct clerical and  
10 typographical errors in the map and legal descrip-  
11 tion.

12 (3) AVAILABILITY.—The map and legal descrip-  
13 tion prepared under paragraph (1) shall be on file  
14 and available for public inspection in the appropriate  
15 offices of the Forest Service and Bureau of Land  
16 Management.

17 (d) ADMINISTRATION.—Subject to valid existing  
18 rights, the area designated as wilderness by this section  
19 shall be administered by the Secretary in accordance with  
20 the Wilderness Act (16 U.S.C. 1131 et seq.), except  
21 that—

22 (1) any reference in that Act to the effective  
23 date shall be considered to be a reference to the date  
24 of enactment of this Act; and

1           (2) any reference in that Act to the Secretary  
2 of Agriculture shall be considered to be a reference  
3 to the Secretary that has jurisdiction over the land  
4 within the Wilderness.

5           (e) FISH AND WILDLIFE.—Nothing in this section af-  
6 fects the jurisdiction or responsibilities of the State with  
7 respect to fish and wildlife in the State.

8           (f) ADJACENT MANAGEMENT.—

9           (1) IN GENERAL.—Nothing in this section cre-  
10 ates any protective perimeter or buffer zone around  
11 the Wilderness.

12           (2) ACTIVITIES OUTSIDE WILDERNESS.—The  
13 fact that a nonwilderness activity or use on land out-  
14 side the Wilderness can be seen or heard within the  
15 Wilderness shall not preclude the activity or use out-  
16 side the boundary of the Wilderness.

17           (g) PROTECTION OF TRIBAL RIGHTS.—Nothing in  
18 this section diminishes any treaty rights of an Indian  
19 tribe.

20           (h) TRANSFER OF ADMINISTRATIVE JURISDIC-  
21 TION.—

22           (1) IN GENERAL.—Administrative jurisdiction  
23 over the approximately 49 acres of Bureau of Land  
24 Management land north of the Umpqua River in T.

1       21 S., R. 11 W., sec. 32, is transferred from the Bu-  
2       reau of Land Management to the Forest Service.

3               (2) ADMINISTRATION.—The Secretary shall ad-  
4       minister the land transferred by paragraph (1) in  
5       accordance with—

6               (A) the Act of March 1, 1911 (commonly  
7       known as the “Weeks Law”) (16 U.S.C. 480 et  
8       seq.); and

9               (B) any laws (including regulations) appli-  
10      cable to the National Forest System.
