A BILL

To amend the Peace Corps Act to reauthorize the Peace Corps, better support current and returned volunteers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) *SHORT TITLE.*—*This Act may be cited as the*
 5 *“Peace Corps Reauthorization Act of 2022”.*

6 (b) *TABLE OF CONTENTS.*—*The table of contents for*

8 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS; INTEGRA-**
 9 **TION OF INFORMATION AGE PEACE CORPS**
 10 **VOLUNTEER OPPORTUNITIES.**

11 *Section 3 of the Peace Corps Act (22 U.S.C. 2502) is*
 12 *amended—*

13 (1) *in subsection (b)—*

1 (A) in paragraph (1), by striking
2 “\$270,000,000 for fiscal year 2000, \$298,000,000
3 for fiscal year 2001, \$327,000,000 for fiscal year
4 2002, and \$365,000,000 for fiscal year 2003”
5 and inserting “\$450,000,000 for each of fiscal
6 years 2021 and 2022, \$500,000,000 for fiscal
7 year 2023, and \$550,000,000 for fiscal year
8 2024”; and

9 (B) in paragraph (2), by striking “that fis-
10 cal year and the subsequent fiscal year” and in-
11 serting “obligation and expenditure through the
12 end of the subsequent fiscal year”;

13 (2) by redesignating subsection (h) as subsection
14 (e); and

15 (3) by adding at the end the following new sub-
16 section:

17 “(f) In recognition of the transformative power of
18 internet access in international development efforts, and, as
19 exemplified by its virtual service pilot initiative, the Peace
20 Corps shall be administered to—

21 “(1) give particular attention to the expansion of
22 those programs, projects, training, and other activi-
23 ties that leverage the internet, as appropriate, for de-
24 velopment, education, and social and economic mobil-
25 ity; and

1 “(2) develop positions for Peace Corps volunteers
2 that include such programs, projects, training, and
3 other activities.”.

4 **SEC. 3. READJUSTMENT ALLOWANCES; EXPEDITED RE-EN-**
5 **ROLLMENT AND TRANSITION ASSISTANCE.**

6 (a) *VOLUNTEERS*.—Section 5 of the Peace Corps Act
7 (22 U.S.C. 2504) is amended—

8 (1) in the first sentence of subsection (b), by in-
9 serting “, safety,” after “health”;

10 (2) in subsection (c)—

11 (A) in the first sentence, by striking “\$125”
12 and inserting “\$375”;

13 (B) by striking “his” each place it appears
14 and inserting “the volunteer’s”; and

15 (C) by striking “he” and inserting “the vol-
16 unteer”;

17 (3) by redesignating subsections (e) through (p)
18 as subsections (d) through (o), respectively;

19 (4) by amending subsection (e), as so redesign-
20 ated—

21 (A) in the subsection heading, by inserting
22 “AND MENTAL HEALTH CARE” after “PRESCRIP-
23 TION OF MEDICATIONS”; and

24 (B) by inserting “concerning the mental
25 health care provided to volunteers during their

1 *service,” after “experts licensed in the field of*
 2 *mental health,”;*

3 *(5) in subsection (f), as so redesignated, by strik-*
 4 *ing “subsequent”;*

5 *(6) in subsection (g), as so redesignated, by strik-*
 6 *ing “he” and inserting “the Director”;*

7 *(7) in subsection (m), as so redesignated—*

8 *(A) in paragraph (2)—*

9 *(i) by striking “subsection (e)” each*
 10 *place it appears and inserting “subsection*
 11 *(d)”;* *and*

12 *(ii) by striking “he” and inserting “the*
 13 *President”;* *and*

14 *(B) in paragraph (4), by striking “sub-*
 15 *section (1)” and inserting “subsection (k)”;*

16 *(8) in subsection (n), as so redesignated, by*
 17 *striking “his” each place it appears and inserting*
 18 *“the volunteer’s”;* *and*

19 *(9) by adding at the end the following new sub-*
 20 *sections:*

21 *“(p) Notwithstanding any other provision of this sec-*
 22 *tion, with respect to Peace Corps volunteers and trainees*
 23 *whose service ended involuntarily as a result of an emer-*
 24 *gency, suspension of operations, or otherwise through no*

1 *fault of the volunteer or trainee, the Director of the Peace*
2 *Corps shall—*

3 “(1) *waive such non-medical or non-security ap-*
4 *plication requirements as the Director may determine*
5 *for the re-enrollment of each such volunteer and train-*
6 *ee during the 2-year period beginning on the date of*
7 *such involuntary end of service;*

8 “(2) *prioritize the medical clearance for each*
9 *such volunteer and trainee to facilitate re-enrollment;*
10 *and*

11 “(3) *permit each such volunteer and trainee, to*
12 *the extent practicable and in consideration of the*
13 *needs of overseas posts and the suitability of the vol-*
14 *unteer or trainee to meet those needs, to resume the*
15 *activity of each such volunteer and trainee at the time*
16 *of the involuntary end of service.*

17 “(q) *The Director of the Peace Corps may authorize*
18 *separation allowances, in amounts determined by the Direc-*
19 *tor, to Peace Corps volunteers and trainees whose service*
20 *ended involuntarily as a result of an emergency, suspension*
21 *of operations, or otherwise through no fault of the volunteer*
22 *or trainee.”.*

23 (b) *VOLUNTEER LEADERS.—Section 6 of the Peace*
24 *Corps Act (22 U.S.C. 2505) is amended—*

1 (1) in paragraph (1), by striking “\$125” and in-
 2 serting “\$375”; and

3 (2) in paragraph (3)—

4 (A) by striking “he” and inserting “the Di-
 5 rector”; and

6 (B) by striking “in section 5(e)” each place
 7 it appears and inserting “in section 5(d)”.

8 **SEC. 4. HEALTH CARE CONTINUATION FOR PEACE CORPS**
 9 **VOLUNTEERS.**

10 Subsection (d) of section 5 of the Peace Corps Act (22
 11 U.S.C. 2504), as redesignated pursuant to section 4, is
 12 amended to read as follows:

13 “(d)(1) Volunteers and trainees shall receive such
 14 health care (including, if necessary, for volunteers and
 15 trainees, services under section 8B) during their service, as
 16 the Director of the Peace Corps may determine to be nec-
 17 essary or appropriate.

18 “(2) Applicants for enrollment shall receive such health
 19 examinations preparatory to their service, applicants for
 20 enrollment who have accepted an invitation to begin a pe-
 21 riod of training under section 8(a) shall receive, pre-
 22 paratory to their service, such immunization, dental care,
 23 and information on prescription options and potential
 24 interactions, as necessary and appropriate and in accord-
 25 ance with subsection (e).

1 “(3) *Returned volunteers shall receive such health ex-*
2 *aminations within six months after termination of their*
3 *service, including services provided in accordance with sec-*
4 *tion 8B (except that the six-month limitation shall not*
5 *apply in the case of such services).*

6 “(4) *Subject to such conditions as the President may*
7 *prescribe, such health care may be provided in any facility*
8 *of any agency of the United States Government, and in such*
9 *cases the appropriation for maintaining and operating*
10 *such facility shall be reimbursed from appropriations avail-*
11 *able under this Act. Health care may not be provided under*
12 *this subsection in a manner inconsistent with the Assisted*
13 *Suicide Funding Restriction Act of 1997 (Public Law 105–*
14 *12).*

15 “(5) *Returned volunteers, including those whose period*
16 *of service is subject to early termination as the result of*
17 *an emergency, shall receive upon termination of their serv-*
18 *ice with the Peace Corps two months of short-term non-serv-*
19 *ice-related health insurance for transition and travel*
20 *(SHIFTT), to provide coverage for a 60-day period within*
21 *which such volunteer will be advised to obtain qualifying*
22 *health insurance, and an opportunity to extend for an addi-*
23 *tional 1 month such SHIFTT insurance, at the expense of*
24 *such volunteer.*

1 “(6) Not later than 30 days before the date on which
2 the period of service of a volunteer or trainee terminates,
3 or 30 days after the date of such termination if such termi-
4 nation is the result of an emergency, the Director of the
5 Peace Corps, in consultation with the Secretary of Health
6 and Human Services, shall provide detailed information to
7 such volunteer or trainee on options for health care after
8 termination other than health care provided by the Peace
9 Corps, including—

10 “(A) where additional, detailed information, in-
11 cluding on the application process and eligibility re-
12 quirements for medical assistance through State plans
13 under title XIX of the Social Security Act (or waiver
14 of State plans), may be obtained, including through
15 external health care ‘navigators’ or health care option
16 identification services available within the public and
17 private sectors;

18 “(B) where detailed information on qualified
19 health plans may be obtained, including through ex-
20 ternal health care ‘navigators’ or health care option
21 identification services available within the public and
22 private sectors; and

23 “(C) if such volunteer or trainee is 25 years of
24 age or younger, detailed information regarding the
25 eligibility of such volunteer or trainee to enroll as a

1 *dependent child in a group health plan or health in-*
 2 *surance coverage in which the parent of such volun-*
 3 *teer or trainee is enrolled if such plan or coverage of-*
 4 *fers such dependent coverage.”.*

5 **SEC. 5. ACCESS TO ANTIMALARIAL DRUGS AND MENSTRUAL**
 6 **PRODUCTS FOR PEACE CORPS VOLUNTEERS.**

7 *Section 5A of the Peace Corps Act (22 U.S.C. 2504a)*
 8 *is amended—*

9 *(1) by striking subsections (c) and (e);*

10 *(2) by redesignating subsection (d) as subsection*
 11 *(e);*

12 *(3) by inserting after subsection (b) the following*
 13 *new subsections:*

14 *“(c) ANTIMALARIAL DRUGS.—*

15 *“(1) IN GENERAL.—The Director of the Peace*
 16 *Corps shall consult with experts at the Centers for*
 17 *Disease Control and Prevention regarding rec-*
 18 *ommendations for prescribing malaria prophylaxis,*
 19 *and implement such recommendations to the extent*
 20 *practicable, in order to provide the best standard of*
 21 *care within the context of the Peace Corps environ-*
 22 *ment.*

23 *“(2) CERTAIN TRAINING.—The Director of the*
 24 *Peace Corps shall ensure that each Peace Corps med-*
 25 *ical officer serving in a malaria-endemic country re-*

1 *ceives training in the recognition of the side effects of*
2 *such medications.*

3 “(d) *ACCESS TO MENSTRUAL PRODUCTS.*—

4 “(1) *IN GENERAL.*—Not later than 180 days
5 *after the date of the enactment of this subsection, the*
6 *Director of the Peace Corps shall establish a com-*
7 *prehensive policy to ensure Peace Corps volunteers*
8 *who require menstrual products are able to access*
9 *such products by—*

10 “(A) *increasing stipends for such volunteers*
11 *to purchase such products; or*

12 “(B) *providing such volunteers with such*
13 *products in the generic product types selected by*
14 *such volunteer, if available in the country of*
15 *service.*

16 “(2) *CONSIDERATION.*—The policy required
17 *under paragraph (1) shall take into consideration the*
18 *availability for purchase locally of menstrual prod-*
19 *ucts, the price of such products, and cultural norms*
20 *regarding menstruation.*

21 “(3) *COST.*—If stipends are increased pursuant
22 *to the policy required under paragraph (1), the Direc-*
23 *tor of the Peace Corps shall ensure that such increase*
24 *is sufficient to cover the average cost within the coun-*

1 *try of service of menstrual products required by vol-*
 2 *unteers.”; and*

3 *(4) in paragraph (1)(A) of subsection (e), as so*
 4 *redesignated, by inserting “, patient confidentiality*
 5 *standards” before “, and guidelines”.*

6 **SEC. 6. CODIFICATION OF EXECUTIVE ORDER 11103.**

7 *The Peace Corps Act is amended by inserting after sec-*
 8 *tion 5A (22 U.S.C. 2504a) the following new section:*

9 **“SEC. 5B. CODIFICATION OF EXECUTIVE ORDER 11103.**

10 *“(a) Executive Order 11103 (22 U.S.C. 2504 note; 28*
 11 *Fed. Reg. 3571; relating to Providing for the Appointment*
 12 *of Former Peace Corps Volunteers to the Civilian Career*
 13 *Services), as amended by Executive Order 12107 (44 Fed.*
 14 *Reg. 1055; relating to the Civil Service Commission and*
 15 *Labor-Management in the Federal Service), as in effect on*
 16 *the day before the date of the enactment of this section, shall*
 17 *remain in effect and have the full force and effect of law,*
 18 *consistent with subsection (b).*

19 *“(b)(1) The period of eligibility for noncompetitive ap-*
 20 *pointment to the civil service provided to an individual by*
 21 *operation of subsection (a), including any individual who*
 22 *is so eligible on the date of the enactment of this section,*
 23 *shall be extended by the total number of days that, during*
 24 *such period—*

1 “(A) a hiring freeze for civilian employees of the
2 *Executive branch is in effect by order of the President*
3 *with respect to any Executive agency at which the in-*
4 *dividual has applied for employment;*

5 “(B) there is a lapse in appropriations with re-
6 *spect to any Executive agency at which the individual*
7 *has applied for employment; or*

8 “(C) the individual is receiving disability com-
9 *penetration under section 8142 of title 5, United States*
10 *Code, based on their service as a Peace Corps volun-*
11 *teer, retroactive to the date the individual applied for*
12 *such compensation.*

13 “(2) *The period of eligibility for noncompetitive ap-*
14 *pointment status to the civil service by operation of sub-*
15 *section (a) shall apply to a Peace Corps volunteer—*

16 “(A) *whose service ended involuntarily as the re-*
17 *sult of a suspension of volunteer operations by the Di-*
18 *rector of the Peace Corps, but shall not last longer*
19 *than 12 months from the date on which such service*
20 *ended involuntarily; or*

21 “(B) *who re-enrolls as a volunteer in the Peace*
22 *Corps after completion of a term of service.*

23 “(3) *In this subsection:*

24 “(A) *The term ‘hiring freeze’ means any memo-*
25 *randum, Executive order, or other action by the*

1 *President that prohibits an Executive agency from*
2 *filling vacant Federal civilian employee positions or*
3 *creating new such positions.*

4 “(B) *The term ‘Executive agency’ has the mean-*
5 *ing given that term in section 105 of title 5, United*
6 *States Code, and includes the United States Postal*
7 *Service and the Postal Regulatory Commission, but*
8 *does not include the Government Accountability Of-*
9 *fice.*

10 “(c) *Subject to subsection (b), Executive Order 11103*
11 *(22 U.S.C. 2504 note; 28 Fed. Reg. 3571; relating to Pro-*
12 *viding for the Appointment of Former Peace Corps Volun-*
13 *teers to the Civilian Career Services), as amended by Execu-*
14 *tive Order 12107 (44 Fed. Reg. 1055; relating to the Civil*
15 *Service Commission and Labor-Management in the Federal*
16 *Service), as in effect on the day before the date of the enact-*
17 *ment of this section, shall, except as set forth herein, remain*
18 *in effect and have the full force and effect of law. In the*
19 *event of a conflict between the language herein and Execu-*
20 *tive Order 11103, the language herein shall prevail.*

21 “(d) *Any volunteer whose service terminated after Jan-*
22 *uary 1, 2020, and who has been certified by the Director*
23 *as having served satisfactorily as a volunteer under the Act*
24 *may, for two years after their separation from the Peace*
25 *Corps, be appointed to a position in any United States de-*

1 *partment, agency, or establishment in the competitive serv-*
 2 *ice under title 5, United States Code without competitive*
 3 *examination and in accordance with such regulations and*
 4 *conditions consistent with this subsection as may be pre-*
 5 *scribed by the Director of the Office of Personnel Manage-*
 6 *ment.”.*

7 **SEC. 7. VOLUNTEERS PROVIDING VIRTUAL SERVICES FOR**
 8 **THE PEACE CORPS.**

9 *The Peace Corps Act is amended by inserting after sec-*
 10 *tion 5B, as added by section 6 of this Act, the following*
 11 *new section:*

12 **“SEC. 5C. VOLUNTEERS PROVIDING VIRTUAL SERVICES**
 13 **FOR THE PEACE CORPS.**

14 *“(a) DECLARATION OF POLICY.—Congress declares*
 15 *that the Peace Corps has a demonstrated ability to deliver*
 16 *information, training, and technical assistance virtually*
 17 *through the internet and other electronic means to commu-*
 18 *nities abroad.*

19 *“(b) AUTHORITY.—The Director of the Peace Corps is*
 20 *authorized to recruit individuals, who may be located with-*
 21 *in the United States or third countries, to provide services*
 22 *virtually by electronic means to communities in host coun-*
 23 *tries to flexibly meet the expressed needs of those countries.*

24 *“(c) ADMINISTRATIVE PROVISIONS.—The Director of*
 25 *the Peace Corps—*

1 “(1) may recruit, train, and accept, on such
2 terms and conditions as the Director may determine
3 necessary or appropriate, the services of individuals,
4 especially those individuals who face barriers to serv-
5 ing physically in a host country, who shall serve on
6 a part-time basis as virtual service volunteers to meet
7 the expressed needs of host countries, such as informa-
8 tion, training, and technical assistance, through the
9 internet or other electronic or virtual means; and

10 “(2) may provide for incidental expenses of such
11 individuals, as determined by the Director to be ap-
12 propriate for the nature of the assignments.

13 “(d) *INDIVIDUALS NOT TO BE CONSIDERED VOLUN-*
14 *TEERS.*—An individual who provides services under the au-
15 *thority of this section shall not be considered to be a volun-*
16 *teer for purposes of section 5 unless the Director of the Peace*
17 *Corps requires the individual to physically serve in the host*
18 *country on a temporary basis.*

19 “(e) *INDIVIDUALS NOT TO BE CONSIDERED FEDERAL*
20 *EMPLOYEES.*—An individual who provides services under
21 *the authority of this section shall not be considered a Fed-*
22 *eral employee except for the purposes described in section*
23 *5(h).’’.*

1 **SEC. 8. PROTECTION OF PEACE CORPS VOLUNTEERS**
2 **AGAINST REPRISAL OR RETALIATION.**

3 *Section 8G of the Peace Corps Act (22 U.S.C. 2507g)*
4 *is amended by adding at the end the following new sub-*
5 *section:*

6 “(d) *PROHIBITION AGAINST REPRISAL OR RETALIA-*
7 *TION.—*

8 “(1) *IN GENERAL.—The Director of the Peace*
9 *Corps shall take all reasonable measures, including*
10 *through the development and implementation of a*
11 *comprehensive policy, to prevent and address reprisal*
12 *or retaliation against a volunteer by any Peace Corps*
13 *officer or employee, or any other person with super-*
14 *visory authority over the volunteer during the volun-*
15 *teer’s period of service.*

16 “(2) *REPORTING AND INVESTIGATION; RELIEF.—*
17 “(A) *IN GENERAL.—A volunteer may report*
18 *a complaint or allegation of reprisal or retalia-*
19 *tion—*

20 “(i) *directly to the Inspector General of*
21 *the Peace Corps, and the Inspector General*
22 *may conduct such investigations and make*
23 *such recommendations with respect to the*
24 *complaint or allegation as the Inspector*
25 *General considers appropriate; and*

1 “(ii) through other channels provided

 3 process for confidential reporting required
 4 in subsection (a).

5 “(B) *RELIEF.*—*The Director of the Peace*
 6 *Corps—*

7 “(i) may order any relief for an af-
 8 firmative finding of a proposed or final res-
 9 olution of a complaint or allegation of re-
 10 prisal or retaliation in accordance with
 11 policies, rules, and procedures of the Peace
 12 Corps; and

13 “(ii) shall ensure such relief is prompt-
 14 ly provided to the volunteer.

15 “(3) *APPEAL.*—

16 “(A) *IN GENERAL.*—*A volunteer may ap-*
 17 *peal to the Director of the Peace Corps any pro-*
 18 *posed or final resolution of a complaint or alle-*
 19 *gation of reprisal or retaliation.*

20 “(B) *RULE OF CONSTRUCTION.*—*Nothing in*
 21 *this paragraph may be construed to affect any*
 22 *other right of recourse a volunteer may have*
 23 *under any other provision of law.*

24 “(4) *NOTIFICATION OF RIGHTS AND REM-*
 25 *EDIES.*—*The Director of the Peace Corps shall ensure*

1 *that volunteers are informed in writing of the rights*
2 *and remedies provided under this section.*

3 “(5) *DISPUTE MEDIATION.*—*The Director of the*
4 *Peace Corps shall offer the opportunity for volunteers*
5 *to resolve disputes concerning a complaint or allega-*
6 *tion of reprisal or retaliation through mediation in*
7 *accordance with procedures developed by the Peace*
8 *Corps.*

9 “(6) *STAFF MEMBER AND VOLUNTEER COOPERA-*
10 *TION.*—*The Director of the Peace Corps may take*
11 *such disciplinary or other administrative action, in-*
12 *cluding termination of service or finding of ineligi-*
13 *bility for re-employment or reinstatement, with re-*
14 *spect to a staff member or volunteer who unreason-*
15 *ably refuses to cooperate with an investigation con-*
16 *ducted by the Inspector General of the Peace Corps*
17 *into a complaint or allegation of reprisal or retalia-*
18 *tion.*

19 “(7) *DEFINITIONS.*—*In this subsection:*

20 “(A) *REPRISAL OR RETALIATION.*—*The*
21 *term ‘reprisal or retaliation’ means taking,*
22 *threatening to take, or initiating adverse admin-*
23 *istrative action against a volunteer because the*
24 *volunteer made a report pursuant to subsection*
25 *(a) or otherwise disclosed to a covered official or*

1 *office any information pertaining to waste,*
2 *fraud, abuse of authority, misconduct, mis-*
3 *management, violations of law, or a significant*
4 *threat to health and safety, whenever the activity*
5 *or occurrence complained of is based upon the*
6 *reasonable belief of the volunteer that it has*
7 *taken place.*

8 “(B) COVERED OFFICIAL OR OFFICE.—The
9 *term ‘covered official or office’ means any of the*
10 *following:*

11 “(i) *Any Peace Corps employee, in-*
12 *cluding an employee of the Office of Inspec-*
13 *tor General.*

14 “(ii) *A Member of Congress or a rep-*
15 *resentative of a committee of Congress.*

16 “(iii) *An Inspector General (other than*
17 *the Peace Corps Inspector General).*

18 “(iv) *The Government Accountability*
19 *Office.*

20 “(v) *An authorized official of the De-*
21 *partment of Justice or other law enforce-*
22 *ment agency.*

23 “(vi) *A United States court or grand*
24 *jury.”.*

1 **SEC. 9. COMPREHENSIVE ILLEGAL DRUG USE POLICY WITH**
 2 **RESPECT TO PEACE CORPS VOLUNTEERS.**

3 *The Peace Corps Act is amended by inserting after sec-*

 22 *views of experts in the field of substance abuse, and shall*
 23 *consult with the Committee on Foreign Affairs of the House*
 24 *of Representatives and the Committee on Foreign Relations*
 25 *of the Senate.*

1 “(c) *REPORT*.—Not later than one year after the date
 2 of the enactment of this Act, the Director shall submit to
 3 the Committee on Foreign Affairs of the House of Represent-
 4 atives and the Committee on Foreign Relations of the Sen-
 5 ate a report on the illegal drug use policy required to be
 6 developed and implemented under this section.”.

4 (D) as subparagraph (G); and

5 (iv) by inserting after subparagraph
6 (C) the following new subparagraphs:

7 “(D) make recommendations for utilizing
8 the expertise of returned Peace Corps volunteers
9 in fulfilling the goals of the Peace Corps;

10 “(E) make recommendations for increasing
11 recruitment of volunteers from diverse back-
12 grounds and better supporting such volunteers
13 during their training and enrollment in the
14 Peace Corps;

15 “(F) make recommendations to reduce any
16 financial barriers to application, training, or
17 enrollment in the Peace Corps, including a vol-
18 unteer’s medical expenses and other out-of-pocket
19 costs; and”;

20 (2) in subsection (c)—

21 (A) in paragraph (2)—

22 (i) in subparagraph (A)—

23 (I) in the first sentence—

24 (aa) by striking “fifteen”
25 and inserting “seven”; and

1 (bb) by striking “the Presi-
2 dent, by and with the advice and
3 consent of the Senate” and insert-
4 ing “the Director of the Peace
5 Corps”; and

6 (II) by striking the second sen-
7 tence and inserting the following new
8 sentence: “At least four of such mem-
9 bers shall be returned Peace Corps vol-
10 unteers, and not more than four of
11 such members may be members of the
12 same political party.”;

1 *sidered volunteers under section 5 and shall not be deemed*
 2 *a Federal employee except for the purposes described in sec-*
 3 *tion 5(h). The Director may provide for incidental expenses*
 4 *of domestic volunteers, as determined by the Director to be*
 5 *appropriate for the nature of the assignments.”.*

6 (6) *a review of these screening guidelines, con-*
7 *ducted by a panel of certified and qualified medical*
8 *professionals in the United States, that evaluates*
9 *these standards based on scientific evidence and men-*
10 *tal health research and proposes relevant updates or*
11 *additions to current guidance.*

12 (d) *REPORT ON VOLUNTEER MEDICAL EVACU-*
13 *ATIONS.—Not later than the first May 1 occurring after the*
