A BILL

To amend title 40, United States Code, to require the Administrator of General Services to enter into a cooperative agreement with the National Children's Museum to provide the National Children's Museum rental space without charge in the Ronald Reagan Building and International Trade Center, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Children’s
5 Museum Act”.

6 **SEC. 2. NATIONAL CHILDREN’S MUSEUM.**

7 (a) FINDINGS.—Congress finds that—

8 (1) the Museum and Library Services Act of
9 2003 (Public Law 108–81) designated the Capital
10 Children’s Museum, the predecessor to the National
11 Children’s Museum, as the “National Children’s Mu-
12 seum”;

13 (2) the National Children’s Museum operates
14 under section 501(C)(3) of the Internal Revenue
15 Code of 1986 and is organized under the laws of the
16 District of Columbia;

17 (3) the mission of the National Children’s Mu-
18 seum is to inspire children to care about and change
19 the world; and

20 (4) the National Children’s Museum is located
21 in the federally owned Ronald Reagan Building and
22 International Trade Center.

23 (b) NATIONAL CHILDREN’S MUSEUM.—Chapter 67
24 of title 40, United States Code, is amended by adding at
25 the end the following:

1 **“§ 6735. National Children’s Museum**

2 “(a) IN GENERAL.— Not later than 30 days after
3 the date of enactment of this section, the Administrator
4 of General Services shall enter into a cooperative agree-
5 ment with the National Children’s Museum for the oper-
6 ation of the National Children’s Museum in the approxi-
7 mately 32,369 square feet of space commonly known as
8 suite C-001 (hereinafter referred to as the ‘Space’) of the
9 Ronald Reagan Building and International Trade Center
10 for the duration of the retail space license agreement be-
11 tween Trade Center Management Associates, LLC, or a
12 successor entity, and the Museum, dated December 4,
13 2017, including any exercised renewal options.

14 “(b) CONTENTS.—The cooperative agreement under
15 subsection (a) shall include provisions that—

16 “(1) require, for the period in which the Gen-
17 eral Services Administration owns or controls the
18 Space, the General Services Administration to pro-
19 vide rent for the Space; and

20 “(2) terminate such agreement if—

21 “(A) the Museum does not continue to
22 qualify as a nonprofit organization under sec-
23 tion 501(c)(3) of the Internal Revenue Code of
24 1986; and

25 “(B) the Museum no longer uses the Space
26 as a children’s museum; and

1 “(3) prohibits the Museum from transferring
2 the interest in such agreement.

3 “(c) SOURCE OF FUNDS.—To carry out this section,
4 the Administrator shall use funds derived from—

5 “(1) the Pennsylvania Avenue Development
6 Corporation fund; or

7 “(2) the International Trade Center fund.

8 “(d) REPORT.—The cooperative agreement under
9 subsection (a) shall require the National Children’s Mu-
10 seum to submit to the Committee on Transportation and
11 Infrastructure of the House of Representatives and the
12 Committee on Environment and Public Works of the Sen-
13 ate an annual report on the operations and finances of
14 the Museum.”.

15 (c) CLERICAL AMENDMENT.—The analysis for chap-
16 ter 67 of title 40, United States Code, is amended by add-
17 ing at the end the following:

 “6735. National Children’s Museum.”.
