A BILL

To amend title 28 of the United States Code to prevent the transfer of actions arising under the antitrust laws in which a State is a complainant.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “State Antitrust Enforce-*
 5 *ment Venue Act of 2022”.*

6 **SEC. 2. AMENDMENTS.**

7 *Section 1407 of title 28 of the United States Code is*
 8 *amended—*

9 *(1) in subsection (g) by inserting “or a State”*
 10 *after “United States”, and*

11 *(2) by striking subsection (h).*

12 **SEC. 3. EFFECTIVE DATE.**

13 *This Act and the amendments made by this Act, shall*
 14 *take effect on June 1, 2021.*

Amend the title so as to read: “A bill to promote competition by preventing the transfer of actions arising under the antitrust laws in which a State is a complainant.”.
