AN ACT

To amend title III of the Public Health Service Act to reauthorize the National Center on Birth Defects and Developmental Disabilities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Improving the Health
3 of Children Act”.

4 **SEC. 2. REAUTHORIZATION OF THE NATIONAL CENTER ON**
5 **BIRTH DEFECTS AND DEVELOPMENTAL DIS-**
6 **ABILITIES.**

7 Section 317C of the Public Health Service Act (42
8 U.S.C. 247b-4) is amended—

9 (1) by striking subsection (a)(4) and inserting
10 the following:

11 “(4) SPECIFIC PROGRAMS.—The Secretary, act-
12 ing through the Director of the Center, shall con-
13 tinue to carry out programs related to—

14 “(A) early identification of developmental
15 delay and disability;

16 “(B) birth defects;

17 “(C) folic acid;

18 “(D) cerebral palsy;

19 “(E) intellectual disabilities;

20 “(F) child development;

21 “(G) newborn screening;

22 “(H) autism;

23 “(I) fragile X syndrome;

24 “(J) fetal alcohol spectrum disorders and
25 other conditions related to prenatal substance
26 use;

1 “(K) pediatric genetic disorders;
2 “(L) neuromuscular diseases;
3 “(M) congenital heart defects;
4 “(N) attention-deficit/hyperactivity dis-
5 order;
6 “(O) stillbirth;
7 “(P) Tourette Syndrome; or
8 “(Q) any other relevant disease, disability,
9 disorder, or condition, as determined the Sec-
10 retary.”;

11 (2) in subsection (e), in the matter preceding
12 paragraph (1), by striking “Not later than February
13 1” and all that follows through “2 fiscal years—”
14 and inserting the following: “The Secretary shall
15 submit biennially to the Committee on Energy and
16 Commerce of the House of Representatives, and the
17 Committee on Health, Education, Labor, and Pen-
18 sions of the Senate, a report that—”; and

19 (3) in subsection (f), by striking “such sums as
20 may be necessary for each of fiscal years 2003
21 through 2007” and inserting “\$186,010,000 for
22 each of fiscal years 2022 through 2026”.

1 **SEC. 3. EFFECTS OF FOLIC ACID IN PREVENTION OF BIRTH**
2 **DEFECTS.**

3 Section 317J of the Public Health Service Act (42
4 U.S.C. 247b–11) is amended by striking subsection (e)
5 (relating to authorization of appropriations).
