A BILL

To amend title IV of the Social Security Act to establish a demonstration grant program to provide emergency relief to foster youth and improve pre-placement services offered by foster care stabilization agencies, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Foster Care Stabiliza-
5 tion Act of 2022”.

1 **SEC. 2. GRANTS TO IMPROVE PRE-PLACEMENT SERVICES**
2 **FOR FOSTER YOUTH.**

3 Section 426 of the Social Security Act (42 U.S.C.
4 626) is amended by adding at the end the following:

5 “(d) GRANTS TO IMPROVE PRE-PLACEMENT SERV-
6 ICES FOR FOSTER YOUTH.—

7 “(1) ESTABLISHMENT.—The Secretary shall
8 award 3 demonstration grants of not more than
9 \$1,000,000 to foster care stabilization agencies for
10 the purpose of providing emergency relief to foster
11 youth and improving pre-placement services for fos-
12 ter youth waiting for placement.

13 “(2) DURATION.—A foster care stabilization
14 agency that receives a grant under this subsection
15 shall have 3 years to spend funds awarded by the
16 grant and return any unused grant funds to the Sec-
17 retary.

18 “(3) APPLICATION.—A foster care stabilization
19 agency that desires to receive a grant under this
20 subsection shall submit to the Secretary an applica-
21 tion at such time, in such manner, and containing
22 such information as the Secretary may require, that
23 shall include the following:

24 “(A) A description of how grant funds will
25 be used to provide emergency relief to foster
26 youth by the foster care stabilization agency.

1 “(B) A description of how grant funds will
2 be used to improve pre-placement services of-
3 fered by the foster care stabilization agency.

4 “(4) APPLICATION DISSEMINATION.—The Sec-
5 retary shall ensure that the solicitation of applica-
6 tions for a grant under this subsection is posted
7 publically on the website of the Administration for
8 Children and Families and shall make special dis-
9 semination efforts to rural areas and among Indian
10 Tribes, Tribal organizations, and Native Hawaiian
11 organizations.

12 “(5) USE OF FUNDS.—A grant awarded under
13 this subsection may be used to carry out any of the
14 following activities:

15 “(A) Hiring of personnel necessary to pro-
16 vide emergency relief to foster youth and ensure
17 that services, resources, and assistance reach
18 such youth.

19 “(B) Provision of clothing and other per-
20 sonal necessities to a foster youth for a total
21 not to exceed \$250 per foster youth, per year.

22 “(C) Purchase of food and equipment
23 needed to prepare food for foster youth.

1 “(D) Provision of service and support to
2 prevent and respond to occurrences of child
3 abuse and neglect with respect to foster youth.

4 “(E) Any other extraordinary or emer-
5 gency assistance needed to promote the safety
6 and self-sufficiency of foster youth.

7 “(F) Any other purpose that the Secretary
8 determines appropriate.

9 “(6) RESERVATION.—The Secretary shall re-
10 serve \$45,000 of any amounts referred to in para-
11 graph (9) for administration, oversight, and tech-
12 nical assistance activities related to this subsection.

13 “(7) REPORT.—The Secretary shall submit to
14 the Congress a report that—

15 “(A) describes how grants awarded under
16 this subsection have been used to provide emer-
17 gency relief to foster youth;

18 “(B) describe how grants awarded under
19 this subsection have been used on pre-place-
20 ment services;

21 “(C) contains data on the extent of cloth-
22 ing and other necessities purchased with grant
23 funds awarded under this subsection that have
24 been provided to foster youth;

1 “(D) provides an evaluation of case out-
2 comes for foster youth who have benefitted
3 from grant funds; and

4 “(E) states the number of home transfers
5 for each foster youth that has benefitted from
6 grant funds.

7 “(8) DEFINITIONS.—In this subsection:

8 “(A) FOSTER CARE STABILIZATION AGEN-
9 CY.—The term ‘foster care stabilization agency’
10 means a local public or private nonprofit entity,
11 including a community or faith-based organiza-
12 tion, with expertise and experience providing di-
13 rect services to 1 or more of the following:

14 “(i) Children who are under the care
15 and placement responsibility of a State or
16 tribal agency that administers a plan
17 under this part or part E.

18 “(ii) Foster youth who have not at-
19 tained 18 years of age.

20 “(iii) Foster youth who have attained
21 18 years of age.

22 “(B) FOSTER YOUTH.—The term ‘foster
23 youth’ means an individual in foster care who
24 has not attained 26 years of age.

1 “(C) HOME TRANSFER.—The term ‘home
2 transfer’ means the initial placement of a foster
3 youth in foster care, and any subsequent place-
4 ment of that foster youth while in foster care.

5 “(9) FUNDING.—To the extent that the total of
6 the amounts made available under subsection (a) for
7 a fiscal year exceeds \$5,000,000 more than the
8 amount so made available for fiscal year 2021, the
9 Secretary shall use the amounts to carry out this
10 subsection.”.
