AN ACT

To authorize the Secretary of the Interior to issue a right-of-way permit with respect to a natural gas distribution pipeline within Valley Forge National Historical Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Valley Forge Park Re-
3 alignment Permit and Promise Act”.

4 **SEC. 2. RIGHT-OF-WAY PERMIT FOR NATURAL GAS DIS-**
5 **TRIBUTION MAIN SEGMENT AT VALLEY**
6 **FORGE NHP.**

7 (a) IN GENERAL.—Notwithstanding any other provi-
8 sion of law, the Secretary may issue a right-of-way permit
9 pursuant to part 14 of title 36, Code of Federal Regula-
10 tions (as in effect on the date of the enactment of this
11 Act), for the covered main segment if the covered main
12 segment is relocated to a proposed realignment of Valley
13 Forge Park Road and North Gulph Road within the Park.

14 (b) SCOPE OF AUTHORITY.—The authority to grant
15 a right-of-way permit under subsection (a) shall apply only
16 to the covered main segment and shall not apply to any
17 other part of the natural gas distribution main system or
18 any other pipeline system within the Park.

19 (c) DEFINITIONS.—In this section:

20 (1) COVERED MAIN SEGMENT.—The term “cov-
21 ered main segment” means the portions of the nat-
22 ural gas distribution main (including all appur-
23 tenances used in the operation of such main) within
24 the Park—

25 (A) existing on the date of the enactment
26 of this Act; and

1 (B) that are located under, along, or adja-
2 cent to the segments of North Gulph Road and
3 Valley Forge Park Road (SR3039 and SR0023
4 respectively, as those roads were aligned on
5 January 21, 2022) that are between—

6 (i) the intersection of North Gulph
7 Road with Richards Road; and

8 (ii) a point on Valley Forge Park
9 Road located 500 feet northwest of its
10 intersection with County Line Road.

11 (2) PARK.—The term “Park” means Valley
12 Forge National Historical Park.

13 (3) SECRETARY.—The term “Secretary” means
14 the Secretary of the Interior.

15 **SEC. 3. DETERMINATION OF BUDGETARY EFFECTS.**

16 The budgetary effects of this Act, for the purpose of
17 complying with the Statutory Pay-As-You-Go Act of 2010,
18 shall be determined by reference to the latest statement
19 titled “Budgetary Effects of PAYGO Legislation” for this
20 Act, submitted for printing in the Congressional Record
21 by the Chairman of the House Budget Committee, pro-

- 1 vided that such statement has been submitted prior to the
- 2 vote on passage.
