## RESOLUTION

Providing for consideration of the bill (S. 3522) to provide enhanced authority for the President to enter into agreements with the Government of Ukraine to lend or lease defense articles to that Government to protect civilian populations in Ukraine from Russian military invasion, and for other purposes; and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (S.  
3 3522) to provide enhanced authority for the President to

1 enter into agreements with the Government of Ukraine to  
2 lend or lease defense articles to that Government to pro-  
3 tect civilian populations in Ukraine from Russian military  
4 invasion, and for other purposes. All points of order  
5 against consideration of the bill are waived. The bill shall  
6 be considered as read. All points of order against provi-  
7 sions in the bill are waived. The previous question shall  
8 be considered as ordered on the bill and on any amend-  
9 ment thereto to final passage without intervening motion  
10 except: (1) one hour of debate equally divided and con-  
11 trolled by the chair and ranking minority member of the  
12 Committee on Foreign Affairs or their respective des-  
13 ignees; and (2) one motion to commit.

14 SEC. 2. House Resolution 1035 is hereby adopted.

15 SEC. 3. House Resolution 188, agreed to March 8,  
16 2021 (as most recently amended by House Resolution  
17 1017, agreed to March 31, 2022), is amended by striking  
18 “April 29, 2022” each place it appears and inserting (in  
19 each instance) “May 13, 2022”.
