rity workforce by applying the personnel system under title 5, United States Code, to employees of the Transportation Security Administration who provide screening of all passengers and property, and for other purposes; providing for consideration of the bill (H.R. 2499) to amend chapter 81 of title 5, United States Code, to create a presumption that a disability or death of a Federal employee in fire protection activities caused by any of certain diseases is the result of the performance of such employees duty, and for other purposes; providing for consideration of the bill (H.R. 5129) to amend the Community Services Block Grant Act to reauthorize and modernize the Act; providing for consideration of the bill (H.R. 7691) making emergency supplemental appropriations for assistance for the situation in Ukraine for the fiscal year ending September 30, 2022, and for other purposes; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 903) to enhance the security operations of the Transpor-
4 tation Security Administration and stability of the trans-
5 portation security workforce by applying the personnel
6 system under title 5, United States Code, to employees
7 of the Transportation Security Administration who pro-
8 vide screening of all passengers and property, and for
9 other purposes. All points of order against consideration
10 of the bill are waived. In lieu of the amendment in the
11 nature of a substitute recommended by the Committee on
12 Homeland Security now printed in the bill, an amendment

1 in the nature of a substitute consisting of the text of Rules
2 Committee Print 117–40, modified by the amendment
3 printed in part A of the report of the Committee on Rules
4 accompanying this resolution, shall be considered as
5 adopted. The bill, as amended, shall be considered as read.
6 All points of order against provisions in the bill, as amend-
7 ed, are waived. The previous question shall be considered
8 as ordered on the bill, as amended, and on any further
9 amendment thereto, to final passage without intervening
10 motion except: (1) one hour of debate equally divided and
11 controlled by the chair and ranking minority member of
12 the Committee on Homeland Security or their respective
13 designees; (2) the further amendments described in sec-
14 tion 2 of this resolution; (3) the amendments en bloc de-
15 scribed in section 3 of this resolution; and (4) one motion
16 to recommit.

17 SEC. 2. After debate pursuant to the first section of
18 this resolution, each further amendment printed in part
19 B of the report of the Committee on Rules not earlier con-
20 sidered as part of amendments en bloc pursuant to section
21 3 of this resolution shall be considered only in the order
22 printed in the report, may be offered only by a Member
23 designated in the report, shall be considered as read, shall
24 be debatable for the time specified in the report equally
25 divided and controlled by the proponent and an opponent,

1 may be withdrawn by the proponent at any time before
2 the question is put thereon, shall not be subject to amend-
3 ment, and shall not be subject to a demand for division
4 of the question.

5 SEC. 3. It shall be in order at any time after debate
6 pursuant to the first section of this resolution for the chair
7 of the Committee on Homeland Security or his designee
8 to offer amendments en bloc consisting of further amend-
9 ments printed in part B of the report of the Committee
10 on Rules accompanying this resolution not earlier disposed
11 of. Amendments en bloc offered pursuant to this section
12 shall be considered as read, shall be debatable for 20 min-
13 utes equally divided and controlled by the chair and rank-
14 ing minority member of the Committee on Homeland Se-
15 curity or their respective designees, shall not be subject
16 to amendment, and shall not be subject to a demand for
17 division of the question.

18 SEC. 4. All points of order against the further amend-
19 ments printed in part B of the report of the Committee
20 on Rules or amendments en bloc described in section 3
21 of this resolution are waived.

22 SEC. 5. Upon adoption of this resolution it shall be
23 in order to consider in the House the bill (H.R. 2499)
24 to amend chapter 81 of title 5, United States Code, to
25 create a presumption that a disability or death of a Fed-

1 eral employee in fire protection activities caused by any
2 of certain diseases is the result of the performance of such
3 employees duty, and for other purposes. All points of order
4 against consideration of the bill are waived. In lieu of the
5 amendment in the nature of a substitute recommended by
6 the Committee on Education and Labor now printed in
7 the bill, an amendment in the nature of a substitute con-
8 sisting of the text of Rules Committee Print 117-41,
9 modified by the amendment printed in part C of the report
10 of the Committee on Rules accompanying this resolution,
11 shall be considered as adopted. The bill, as amended, shall
12 be considered as read. All points of order against provi-
13 sions in the bill, as amended, are waived. The previous
14 question shall be considered as ordered on the bill, as
15 amended, and on any further amendment thereto, to final
16 passage without intervening motion except: (1) one hour
17 of debate equally divided and controlled by the chair and
18 ranking minority member of the Committee on Education
19 and Labor or their respective designees; (2) the further
20 amendments described in section 6 of this resolution; (3)
21 the amendments en bloc described in section 7 of this reso-
22 lution; and (4) one motion to recommit.

23 SEC. 6. After debate pursuant to section 5 of this
24 resolution, each further amendment printed in part D of
25 the report of the Committee on Rules not earlier consid-

1 ered as part of amendments en bloc pursuant to section
2 7 of this resolution shall be considered only in the order
3 printed in the report, may be offered only by a Member
4 designated in the report, shall be considered as read, shall
5 be debatable for the time specified in the report equally
6 divided and controlled by the proponent and an opponent,
7 may be withdrawn by the proponent at any time before
8 the question is put thereon, shall not be subject to amend-
9 ment, and shall not be subject to a demand for division
10 of the question.

11 SEC. 7. It shall be in order at any time after debate
12 pursuant to section 5 of this resolution for the chair of
13 the Committee on Education and Labor or his designee
14 to offer amendments en bloc consisting of further amend-
15 ments printed in part D of the report of the Committee
16 on Rules accompanying this resolution not earlier disposed
17 of. Amendments en bloc offered pursuant to this section
18 shall be considered as read, shall be debatable for 20 min-
19 utes equally divided and controlled by the chair and rank-
20 ing minority member of the Committee on Education and
21 Labor or their respective designees, shall not be subject
22 to amendment, and shall not be subject to a demand for
23 division of the question.

24 SEC. 8. All points of order against the further amend-
25 ments printed in part D of the report of the Committee

1 on Rules or amendments en bloc described in section 7
2 of this resolution are waived.

3 SEC. 9. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 5129)
5 to amend the Community Services Block Grant Act to re-
6 authorize and modernize the Act. All points of order
7 against consideration of the bill are waived. In lieu of the
8 amendment in the nature of a substitute recommended by
9 the Committee on Education and Labor now printed in
10 the bill, an amendment in the nature of a substitute con-
11 sisting of the text of Rules Committee Print 117-42,
12 modified by the amendment printed in part E of the report
13 of the Committee on Rules accompanying this resolution,
14 shall be considered as adopted. The bill, as amended, shall
15 be considered as read. All points of order against provi-
16 sions in the bill, as amended, are waived. The previous
17 question shall be considered as ordered on the bill, as
18 amended, and on any further amendment thereto, to final
19 passage without intervening motion except: (1) one hour
20 of debate equally divided and controlled by the chair and
21 ranking minority member of the Committee on Education
22 and Labor or their respective designees; (2) the further
23 amendments described in section 10 of this resolution; (3)
24 the amendments en bloc described in section 11 of this
25 resolution; and (4) one motion to recommit.

1 SEC. 10. After debate pursuant to section 9 of this
2 resolution, each further amendment printed in part F of
3 the report of the Committee on Rules not earlier consid-
4 ered as part of amendments en bloc pursuant to section
5 11 of this resolution shall be considered only in the order
6 printed in the report, may be offered only by a Member
7 designated in the report, shall be considered as read, shall
8 be debatable for the time specified in the report equally
9 divided and controlled by the proponent and an opponent,
10 may be withdrawn by the proponent at any time before
11 the question is put thereon, shall not be subject to amend-
12 ment, and shall not be subject to a demand for division
13 of the question.

14 SEC. 11. It shall be in order at any time after debate
15 pursuant to section 9 of this resolution for the chair of
16 the Committee on Education and Labor or his designee
17 to offer amendments en bloc consisting of further amend-
18 ments printed in part F of the report of the Committee
19 on Rules accompanying this resolution not earlier disposed
20 of. Amendments en bloc offered pursuant to this section
21 shall be considered as read, shall be debatable for 20 min-
22 utes equally divided and controlled by the chair and rank-
23 ing minority member of the Committee on Education and
24 Labor or their respective designees, shall not be subject

1 to amendment, and shall not be subject to a demand for
2 division of the question.

3 SEC. 12. All points of order against the further
4 amendments printed in part F of the report of the Com-
5 mittee on Rules or amendments en bloc described in sec-
6 tion 11 of this resolution are waived.

7 SEC. 13. House Resolution 1096 is hereby adopted.

8 SEC. 14. House Resolution 188, agreed to March 8,
9 2021 (as most recently amended by House Resolution
10 1065, agreed to April 28, 2022), is amended by striking
11 “May 13, 2022” each place it appears and inserting (in
12 each instance) “June 10, 2022”.

13 SEC. 15. Notwithstanding clause 8 of rule XX, fur-
14 ther proceedings on a vote by the yeas and nays on the
15 question of adoption of a motion that the House suspend
16 the rules offered on the legislative day of May 10, 2022,
17 or May 11, 2022, may be postponed through the legislative
18 day of May 18, 2022.

19 SEC. 16. Upon adoption of this resolution it shall be
20 in order to consider in the House the bill (H.R. 7691)
21 making emergency supplemental appropriations for assist-
22 ance for the situation in Ukraine for the fiscal year ending
23 September 30, 2022, and for other purposes. All points
24 of order against consideration of the bill are waived. The
25 amendment printed in part G of the report of the Com-

1 mittee on Rules accompanying this resolution shall be con-
2 sidered as adopted. The bill, as amended, shall be consid-
3 ered as read. All points of order against provisions in the
4 bill, as amended, are waived. The previous question shall
5 be considered as ordered on the bill, as amended, and on
6 any further amendment thereto, to final passage without
7 intervening motion except: (1) one hour of debate equally
8 divided and controlled by the chair and ranking minority
9 member of the Committee on Appropriations or their re-
10 spective designees; and (2) one motion to recommit.
