RESOLUTION

Providing for consideration of the bill (H.R. 6531) to provide an increased allocation of funding under certain programs for assistance in areas of persistent poverty, and for other purposes; providing for consideration of the bill (H.R. 7309) to reauthorize the Workforce Innovation and Opportunity Act; and providing for consideration of the bill (S. 2938) to designate the United States Courthouse and Federal Building located at 111 North

Adams Street in Tallahassee, Florida, as the “Joseph Woodrow Hatchett United States Courthouse and Federal Building”, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 6531) to provide an increased allocation of funding under
4 certain programs for assistance in areas of persistent pov-
5 erty, and for other purposes. All points of order against
6 consideration of the bill are waived. An amendment in the
7 nature of a substitute consisting of the text of Rules Com-
8 mittee Print 117–44, modified by the amendment printed
9 in part A of the report of the Committee on Rules accom-
10 panying this resolution, shall be considered as adopted.
11 The bill, as amended, shall be considered as read. All
12 points of order against provisions in the bill, as amended,
13 are waived. The previous question shall be considered as
14 ordered on the bill, as amended, and on any further
15 amendment thereto, to final passage without intervening
16 motion except: (1) one hour of debate equally divided and
17 controlled by the chair and ranking minority member of
18 the Committee on Oversight and Reform or their respec-
19 tive designees; and (2) one motion to recommit.

20 SEC. 2. Upon adoption of this resolution it shall be
21 in order to consider in the House the bill (H.R. 7309)
22 to reauthorize the Workforce Innovation and Opportunity
23 Act. All points of order against consideration of the bill

1 are waived. In lieu of the amendment in the nature of a
2 substitute recommended by the Committee on Education
3 and Labor now printed in the bill, an amendment in the
4 nature of a substitute consisting of the text of Rules Com-
5 mittee Print 117-43, modified by the amendment printed
6 in part B of the report of the Committee on Rules accom-
7 panying this resolution, shall be considered as adopted.
8 The bill, as amended, shall be considered as read. All
9 points of order against provisions in the bill, as amended,
10 are waived. The previous question shall be considered as
11 ordered on the bill, as amended, and on any further
12 amendment thereto, to final passage without intervening
13 motion except: (1) one hour of debate equally divided and
14 controlled by the chair and ranking minority member of
15 the Committee on Education and Labor or their respective
16 designees; (2) the further amendments described in sec-
17 tion 3 of this resolution; (3) the amendments en bloc de-
18 scribed in section 4 of this resolution; and (4) one motion
19 to recommit.

20 SEC. 3. After debate pursuant to section 2 of this
21 resolution, each further amendment printed in part C of
22 the report of the Committee on Rules not earlier consid-
23 ered as part of amendments en bloc pursuant to section
24 4 of this resolution shall be considered only in the order
25 printed in the report, may be offered only by a Member

1 designated in the report, shall be considered as read, shall
2 be debatable for the time specified in the report equally
3 divided and controlled by the proponent and an opponent,
4 may be withdrawn by the proponent at any time before
5 the question is put thereon, shall not be subject to amend-
6 ment, and shall not be subject to a demand for division
7 of the question.

8 SEC. 4. It shall be in order at any time after debate
9 pursuant to section 2 of this resolution for the chair of
10 the Committee on Education and Labor or his designee
11 to offer amendments en bloc consisting of further amend-
12 ments printed in part C of the report of the Committee
13 on Rules accompanying this resolution not earlier disposed
14 of. Amendments en bloc offered pursuant to this section
15 shall be considered as read, shall be debatable for 20 min-
16 utes equally divided and controlled by the chair and rank-
17 ing minority member of the Committee on Education and
18 Labor or their respective designees, shall not be subject
19 to amendment, and shall not be subject to a demand for
20 division of the question.

21 SEC. 5. All points of order against the further amend-
22 ments printed in part C of the report of the Committee
23 on Rules or amendments en bloc described in section 4
24 of this resolution are waived.

1 SEC. 6. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (S. 2938) to
3 designate the United States Courthouse and Federal
4 Building located at 111 North Adams Street in Tallahas-
5 see, Florida, as the “Joseph Woodrow Hatchett United
6 States Courthouse and Federal Building”, and for other
7 purposes. All points of order against consideration of the
8 bill are waived. An amendment in the nature of a sub-
9 stitute consisting of the text of Rules Committee Print
10 117–45 shall be considered as adopted. The bill, as
11 amended, shall be considered as read. All points of order
12 against provisions in the bill, as amended, are waived. The
13 previous question shall be considered as ordered on the
14 bill, as amended, and on any further amendment thereto,
15 to final passage without intervening motion except: (1) one
16 hour of debate equally divided among and controlled by
17 the chair and ranking minority member of the Committee
18 on Oversight and Reform or their respective designees and
19 the chair and ranking minority member of the Committee
20 on Transportation and Infrastructure or their respective
21 designees; and (2) one motion to commit.

22 SEC. 7. House Resolution 1118 is hereby adopted.
