# RESOLUTION

Of inquiry directing the Secretary of the Treasury to provide certain documents in the Secretary's possession to the House of Representatives relating to recovery rebates under section 6428B of the Internal Revenue Code of 1986.

1       *Resolved*, That the Secretary of the Treasury is di-  
2       rected to transmit to the House of Representatives, not  
3       later than 14 days after the adoption of this resolution,

1 copies of any document, record, memo, correspondence, or  
2 other communication, or any portion of any such commu-  
3 nication, that refers or relates to the following:

4           (1) The total number of recovery rebates issued  
5           under section 6428B of the Internal Revenue Code  
6           of 1986 (whether as a credit under subsection (a) of  
7           such section or as a deemed payment under sub-  
8           section (g) of such section), as added by the Amer-  
9           ican Rescue Plan Act of 2021, to incarcerated indi-  
10          viduals, individuals who were nonresident aliens (in-  
11          cluding foreign nationals living outside the United  
12          States) on the date of enactment of such Act, indi-  
13          viduals who were unlawfully present or unauthorized  
14          to work in the United States on that date, and to  
15          any individuals who died before January 1, 2021,  
16          but not including any personally identifiable infor-  
17          mation about any such individual.

18          (2) The total dollar amount of such recovery re-  
19          bates issued to incarcerated individuals, individuals  
20          who were nonresident aliens (including foreign na-  
21          tionals living outside the United States) on the date  
22          of enactment of such Act, individuals who were un-  
23          lawfully present or unauthorized to work in the  
24          United States on that date, and to any individuals  
25          who died before January 1, 2021, but not including

- 1 any personally identifiable information about any
- 2 such individual.
