4 nication in the Secretary's possession, or any portion of
5 any document, record, audio recording, memorandum, call
6 log, correspondence (electronic or otherwise), or other
7 communication in the Secretary's possession, that refers
8 or relates to any of the following:

9 (1) Communication by the Department of
10 Health and Human Services with any person outside
11 of such Department that occurred prior to Sep-
12 tember 7, 2021, regarding interpretations of section
13 1108 of the Social Security Act (42 U.S.C. 1308),
14 insofar as such interpretations pertained to calcula-
15 tion of the limit imposed under such section on the
16 total amount of funds allowed to be certified by the
17 Secretary under title XIX of the Social Security Act
18 (42 U.S.C. 1396 et seq.) for Puerto Rico for fiscal
19 year 2022 and subsequent fiscal years.

20 (2) Internal communications among employees
21 of the Department of Health and Human Services
22 that occurred prior to September 7, 2021, regarding
23 interpretations described in paragraph (1), insofar
24 as such interpretations pertained to the calculation
25 described in such paragraph.

1 (3) Communication by the Department of
2 Health and Human Services with the Government
3 Accountability Office regarding interpretations de-
4 scribed in paragraph (1), insofar as such interpreta-
5 tions pertained to the calculation described in such
6 paragraph, made by the Comptroller General of the
7 United States, as required by section 3105(b) of the
8 Extending Government Funding and Delivering
9 Emergency Assistance Act (Public Law 117–43).
