Ms. SCANLON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 1629) to amend the Federal Food, Drug, and Cosmetic Act with respect to limitations on exclusive approval or licensure of orphan drugs, and for other purposes; providing for consideration of the resolution (H. Res. 275) condemning the horrific shootings in Atlanta, Georgia, on March 16, 2021, and reaffirming the House of Representative's commitment to combating hate, bigotry, and violence

against the Asian-American and Pacific Islander community; and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 1629) to amend the Federal Food, Drug, and Cosmetic  
4 Act with respect to limitations on exclusive approval or  
5 licensure of orphan drugs, and for other purposes. All  
6 points of order against consideration of the bill are waived.  
7 The bill shall be considered as read. All points of order  
8 against provisions in the bill are waived. The previous  
9 question shall be considered as ordered on the bill and on  
10 any amendment thereto to final passage without inter-  
11 vening motion except: (1) one hour of debate equally di-  
12 vided and controlled by the chair and ranking minority  
13 member of the Committee on Energy and Commerce or  
14 their respective designees; and (2) one motion to recom-  
15 mit.

16       SEC. 2. Upon adoption of this resolution it shall be  
17 in order without intervention of any point of order to con-  
18 sider in the House the resolution (H. Res. 275) con-  
19 demning the horrific shootings in Atlanta, Georgia, on  
20 March 16, 2021, and reaffirming the House of Represent-  
21 ative's commitment to combating hate, bigotry, and vio-  
22 lence against the Asian-American and Pacific Islander  
23 community. The resolution shall be considered as read.  
24 The previous question shall be considered as ordered on

1 the resolution and preamble to adoption without inter-  
2 vening motion or demand for division of the question ex-  
3 cept one hour of debate equally divided and controlled by  
4 the chair and ranking minority member of the Committee  
5 on Oversight and Reform or their respective designees.

6 SEC. 3. House Resolution 398 is hereby adopted.

7 SEC. 4. House Resolution 188, agreed to March 8,  
8 2021 (as amended by House Resolution 330, agreed to  
9 April 20, 2021), is amended by striking “May 20, 2021”  
10 each place it appears and inserting (in each instance)  
11 “July 1, 2021”.

12 SEC. 5. (a) At any time through the legislative day  
13 of Thursday, May 20, 2021, the Speaker may entertain  
14 motions offered by the Majority Leader or a designee that  
15 the House suspend the rules as though under clause 1 of  
16 rule XV with respect to multiple measures described in  
17 subsection (b), and the Chair shall put the question on  
18 any such motion without debate or intervening motion.

19 (b) A measure referred to in subsection (a) includes  
20 any measure that was the object of a motion to suspend  
21 the rules on the legislative day of May 17, 2021, or May  
22 18, 2021, in the form as so offered, on which the yeas  
23 and nays were ordered and further proceedings postponed  
24 pursuant to clause 8 of rule XX.

1           (c) Upon the offering of a motion pursuant to sub-  
2 section (a) concerning multiple measures, the ordering of  
3 the yeas and nays on postponed motions to suspend the  
4 rules with respect to such measures is vacated to the end  
5 that all such motions are considered as withdrawn.
