Res. 503) Establishing the Select Committee to Investigate the January 6th Attack on the United States Capitol; and for other purposes.

Ms. SCANLON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2662) to amend the Inspector General Act of 1978, and for other purposes; providing for consideration of the bill (H.R. 3005) to direct the Joint Committee on the Library to replace

the bust of Roger Brooke Taney in the Old Supreme Court Chamber of the United States Capitol with a bust of Thurgood Marshall to be obtained by the Joint Committee on the Library and to remove certain statues from areas of the United States Capitol which are accessible to the public, to remove all statues of individuals who voluntarily served the Confederate States of America from display in the United States Capitol, and for other purposes; providing for consideration of the bill (H.R. 3684) to authorize funds for Federal-aid highways, highway safety programs, and transit programs, and for other purposes; providing for consideration of the resolution (H. Res. 503) Establishing the Select Committee to Investigate the January 6th Attack on the United States Capitol; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 2662) to amend the Inspector General Act of 1978, and
4 for other purposes. All points of order against consider-
5 ation of the bill are waived. The amendment in the nature
6 of a substitute recommended by the Committee on Over-
7 sight and Reform now printed in the bill shall be consid-
8 ered as adopted. The bill, as amended, shall be considered
9 as read. All points of order against provisions in the bill,
10 as amended, are waived. The previous question shall be
11 considered as ordered on the bill, as amended, and on any
12 further amendment thereto, to final passage without inter-
13 vening motion except: (1) one hour of debate equally di-
14 vided and controlled by the chair and ranking minority

1 member of the Committee on Oversight and Reform or
2 their respective designees; (2) the further amendments de-
3 scribed in section 2 of this resolution; (3) the amendments
4 en bloc described in section 3 of this resolution; and (4)
5 one motion to recommit.

6 SEC. 2. After debate pursuant to the first section of
7 this resolution, each further amendment printed in part
8 A of the report of the Committee on Rules not earlier con-
9 sidered as part of amendments en bloc pursuant to section
10 3 of this resolution shall be considered only in the order
11 printed in the report, may be offered only by a Member
12 designated in the report, shall be considered as read, shall
13 be debatable for the time specified in the report equally
14 divided and controlled by the proponent and an opponent,
15 may be withdrawn by the proponent at any time before
16 the question is put thereon, shall not be subject to amend-
17 ment, and shall not be subject to a demand for division
18 of the question.

19 SEC. 3. It shall be in order at any time after debate
20 pursuant to the first section of this resolution for the chair
21 of the Committee on Oversight and Reform or her des-
22 ignee to offer amendments en bloc consisting of further
23 amendments printed in part A of the report of the Com-
24 mittee on Rules accompanying this resolution not earlier
25 disposed of. Amendments en bloc offered pursuant to this

1 section shall be considered as read, shall be debatable for
2 20 minutes equally divided and controlled by the chair and
3 ranking minority member of the Committee on Oversight
4 and Reform or their respective designees, shall not be sub-
5 ject to amendment, and shall not be subject to a demand
6 for division of the question.

7 SEC. 4. All points of order against the further amend-
8 ments printed in part A of the report of the Committee
9 on Rules or amendments en bloc described in section 3
10 of this resolution are waived.

11 SEC. 5. Upon adoption of this resolution it shall be
12 in order to consider in the House the bill (H.R. 3005)
13 to direct the Joint Committee on the Library to replace
14 the bust of Roger Brooke Taney in the Old Supreme Court
15 Chamber of the United States Capitol with a bust of
16 Thurgood Marshall to be obtained by the Joint Committee
17 on the Library and to remove certain statues from areas
18 of the United States Capitol which are accessible to the
19 public, to remove all statues of individuals who voluntarily
20 served the Confederate States of America from display in
21 the United States Capitol, and for other purposes. All
22 points of order against consideration of the bill are waived.
23 The bill shall be considered as read. All points of order
24 against provisions in the bill are waived. The previous
25 question shall be considered as ordered on the bill and on

1 any amendment thereto to final passage without inter-
2 vening motion except: (1) one hour of debate equally di-
3 vided and controlled by the chair and ranking minority
4 member of the Committee on House Administration or
5 their respective designees; and (2) one motion to recom-
6 mit.

7 SEC. 6. Upon adoption of this resolution it shall be
8 in order to consider in the House the bill (H.R. 3684)
9 to authorize funds for Federal-aid highways, highway safe-
10 ty programs, and transit programs, and for other pur-
11 poses. All points of order against consideration of the bill
12 are waived. In lieu of the amendment in the nature of a
13 substitute recommended by the Committee on Transpor-
14 tation and Infrastructure now printed in the bill, an
15 amendment in the nature of a substitute consisting of the
16 text of Rules Committee Print 117-8, modified by Rules
17 Committee Print 117-9 and the amendment printed in
18 part B of the report of the Committee on Rules accom-
19 panying this resolution, shall be considered as adopted.
20 The bill, as amended, shall be considered as read. All
21 points of order against provisions in the bill, as amended,
22 are waived. The previous question shall be considered as
23 ordered on the bill, as amended, and on any further
24 amendment thereto, to final passage without intervening
25 motion except: (1) 90 minutes of debate, with 60 minutes

1 equally divided and controlled by the chair and ranking
2 minority member of the Committee on Transportation and
3 Infrastructure or their respective designees and 30 min-
4 utes equally divided and controlled by the chair and rank-
5 ing minority member of the Committee on Energy and
6 Commerce or their respective designees; (2) any further
7 amendments and amendments en bloc provided by subse-
8 quent order of the House; and (3) one motion to recommit.

9 SEC. 7. Upon adoption of this resolution it shall be
10 in order without intervention of any point of order to con-
11 sider in the House the resolution (H. Res. 503) Estab-
12 lishing the Select Committee to Investigate the January
13 6th Attack on the United States Capitol. The resolution
14 shall be considered as read. The previous question shall
15 be considered as ordered on the resolution and preamble
16 to adoption without intervening motion or demand for di-
17 vision of the question except one hour of debate equally
18 divided and controlled by the chair and ranking minority
19 member of the Committee on Rules or their respective des-
20 ignees.

21 SEC. 8. (a) At any time through the legislative day
22 of Thursday, July 1, 2021, the Speaker may entertain mo-
23 tions offered by the Majority Leader or a designee that
24 the House suspend the rules as though under clause 1 of
25 rule XV with respect to multiple measures described in

1 subsection (b), and the Chair shall put the question on
2 any such motion without debate or intervening motion.

3 (b) A measure referred to in subsection (a) includes
4 any measure that was the object of a motion to suspend
5 the rules on the legislative day of June 28, 2021, or June
6 29, 2021, in the form as so offered, on which the yeas
7 and nays were ordered and further proceedings postponed
8 pursuant to clause 8 of rule XX.

9 (c) Upon the offering of a motion pursuant to sub-
10 section (a) concerning multiple measures, the ordering of
11 the yeas and nays on postponed motions to suspend the
12 rules with respect to such measures is vacated to the end
13 that all such motions are considered as withdrawn.
