RESOLUTION

Providing for consideration of the bill (H.R. 3076) to provide stability to and enhance the services of the United States Postal Service, and for other purposes; providing for consideration of the bill (H.R. 6617) making further continuing appropriations for the fiscal year ending September 30, 2022, and for other purposes; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 3076) to provide stability to and enhance the services of

1 the United States Postal Service, and for other purposes.
2 All points of order against consideration of the bill are
3 waived. In lieu of the amendment in the nature of a sub-
4 stitute recommended by the Committee on Oversight and
5 Reform now printed in the bill, an amendment in the na-
6 ture of a substitute consisting of the text of Rules Com-
7 mittee Print 117-32 shall be considered as adopted. The
8 bill, as amended, shall be considered as read. All points
9 of order against provisions in the bill, as amended, are
10 waived. The previous question shall be considered as or-
11 dered on the bill, as amended, and on any amendment
12 thereto, to final passage without intervening motion ex-
13 cept: (1) one hour of debate equally divided and controlled
14 by the chair and ranking minority member of the Com-
15 mittee on Oversight and Reform or their respective des-
16 ignees; (2) the further amendment printed in the report
17 of the Committee on Rules accompanying this resolution,
18 if offered by the Member designated in the report, which
19 shall be in order without intervention of any point of
20 order, shall be considered as read, shall be separately de-
21 batable for the time specified in the report equally divided
22 and controlled by the proponent and an opponent, and
23 shall not be subject to a demand for division of the ques-
24 tion; and (3) one motion to recommit.

1 SEC. 2. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (H.R. 6617)
3 making further continuing appropriations for the fiscal
4 year ending September 30, 2022, and for other purposes.
5 All points of order against consideration of the bill are
6 waived. The bill shall be considered as read. All points of
7 order against provisions in the bill are waived. The pre-
8 vious question shall be considered as ordered on the bill
9 and on any amendment thereto to final passage without
10 intervening motion except: (1) one hour of debate equally
11 divided among and controlled by the chair and ranking
12 minority member of the Committee on Appropriations or
13 their respective designees; and (2) one motion to recom-
14 mit.

15 SEC. 3. (a) House Concurrent Resolution 69 is here-
16 by adopted.

17 (b) For purposes of the joint session to receive the
18 President of the United States on March 1, 2022, former
19 Members, Delegates, and Resident Commissioners shall
20 not be admitted to the Hall of the House or rooms leading
21 thereto.
