RESOLUTION

Providing for consideration of the bill (H.R. 963) to amend title 9 of the United States Code with respect to arbitration, and providing for consideration of the bill (H.R. 2116) to prohibit discrimination based on an individual's texture or style of hair.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 963) to amend title 9 of the United States Code with re-
4 spect to arbitration. All points of order against consider-

1 ation of the bill are waived. In lieu of the amendment in
2 the nature of a substitute recommended by the Committee
3 on the Judiciary now printed in the bill, an amendment
4 in the nature of a substitute consisting of the text of Rules
5 Committee Print 117-34 shall be considered as adopted.
6 The bill, as amended, shall be considered as read. All
7 points of order against provisions in the bill, as amended,
8 are waived. The previous question shall be considered as
9 ordered on the bill, as amended, and on any amendment
10 thereto, to final passage without intervening motion ex-
11 cept: (1) one hour of debate equally divided and controlled
12 by the chair and ranking minority member of the Com-
13 mittee on the Judiciary or their respective designees; (2)
14 the further amendment printed in the report of the Com-
15 mittee on Rules accompanying this resolution, if offered
16 by the Member designated in the report, which shall be
17 in order without intervention of any point of order, shall
18 be considered as read, shall be separately debatable for
19 the time specified in the report equally divided and con-
20 trolled by the proponent and an opponent, and shall not
21 be subject to a demand for division of the question; and
22 (3) one motion to recommit.

23 SEC. 2. Upon adoption of this resolution it shall be
24 in order to consider in the House the bill (H.R. 2116)
25 to prohibit discrimination based on an individual's texture

1 or style of hair. All points of order against consideration
2 of the bill are waived. In lieu of the amendment in the
3 nature of a substitute recommended by the Committee on
4 the Judiciary now printed in the bill, an amendment in
5 the nature of a substitute consisting of the text of Rules
6 Committee Print 117–36 shall be considered as adopted.
7 The bill, as amended, shall be considered as read. All
8 points of order against provisions in the bill, as amended,
9 are waived. The previous question shall be considered as
10 ordered on the bill, as amended, and on any further
11 amendment thereto, to final passage without intervening
12 motion except: (1) one hour of debate equally divided and
13 controlled by the chair and ranking minority member of
14 the Committee on the Judiciary or their respective des-
15 ignees; and (2) one motion to recommit.
