## A BILL

To designate certain future interstates and high priority  
corridors in Kentucky, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. LOUIE B. NUNN CUMBERLAND EXPRESSWAY.**

4       (a) DESIGNATION AS HIGH PRIORITY CORRIDOR.—

5       Section 1105(c) of the Intermodal Surface Transportation  
6       Efficiency Act of 1991 (Public Law 102–240; 105 Stat.  
7       2032; 133 Stat. 3018) is amended by adding at the end  
8       the following:

9               “(92) The Louie B. Nunn Cumberland Ex-  
10       pressway from the interchange with Interstate 65 in

1 Barren County, Kentucky, east to the interchange  
 2 with U.S. Highway 27 in Somerset, Kentucky.”.

3 (b) DESIGNATION AS FUTURE INTERSTATE.—Sec-  
 4 tion 1105(e)(5)(A) of the Intermodal Surface Transpor-  
 5 tation Efficiency Act of 1991 (Public Law 102–240; 109  
 6 Stat. 597; 133 Stat. 3018) is amended in the first sen-  
 7 tence by striking “and subsection (c)(91)” and inserting  
 8 “subsection (c)(91), and subsection (c)(92)”.

9 (c) NUMBERING OF PARKWAY.—Section  
 10 1105(e)(5)(C)(i) of the Intermodal Surface Transpor-  
 11 tation Efficiency Act of 1991 (Public Law 102–240; 109  
 12 Stat. 598; 133 Stat. 3018) is amended by adding at the  
 13 end the following: “The route referred to in subsection  
 14 (c)(92) is designated as Interstate Route I–365.”.

15 (d) OPERATION OF VEHICLES.—Section 127(l)(3)(A)  
 16 of title 23, United States Code, is amended—

17 (1) in the matter preceding clause (i), in the  
 18 first sentence, by striking “clauses (i) through (iv)  
 19 of this subparagraph” and inserting “clauses (i)  
 20 through (v)”;

21 (2) by adding at the end the following:

22 “(v) The Louie B. Nunn Cumberland  
 23 Expressway (to be designated as a spur of  
 24 Interstate Route 65) from the interchange  
 25 with Interstate 65 in Barren County, Ken-

- 1 tucky, east to the interchange with U.S.
- 2 Highway 27 in Somerset, Kentucky.”.
