A BILL

To establish the Chiricahua National Park in the State of Arizona as a unit of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Chiricahua National
5 Park Act”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) **MONUMENT.**—The term “Monument”
4 means the Chiricahua National Monument estab-
5 lished by Presidential Proclamation 1692 (54 U.S.C.
6 320301 note; 43 Stat. 1946).

7 (2) **PARK.**—The term “Park” means the Chiri-
8 cahua National Park established by section 3(a).

9 (3) **SECRETARY.**—The term “Secretary” means
10 the Secretary of the Interior.

11 (4) **STATE.**—The term “State” means the State
12 of Arizona.

13 **SEC. 3. ESTABLISHMENT OF CHIRICAHUA NATIONAL PARK.**

14 (a) **ESTABLISHMENT.**—To protect, preserve, and in-
15 terpret the rhyolitic rock formations, biodiversity, and
16 other natural and cultural resources of the area, there is
17 established in the State as a unit of the National Park
18 System the Chiricahua National Park.

19 (b) **BOUNDARIES.**—

20 (1) **IN GENERAL.**—The boundaries of the Park
21 are as generally depicted on the map entitled “Chiri-
22 cahua National Park Proposed Boundary”, num-
23 bered 145/156,356, and dated March 2021.

24 (2) **AVAILABILITY OF MAP.**—The map shall be
25 on file and available for public inspection in the ap-
26 propriate offices of the National Park Service.

1 (c) ABOLISHMENT OF CHIRICAHUA NATIONAL
2 MONUMENT.—

3 (1) ABOLISHMENT.—The Monument is abol-
4 ished.

5 (2) INCORPORATION.—The land and any inter-
6 est in land that constitute the Monument (as in ex-
7 istence on the day before the date of enactment of
8 this Act) are incorporated in, and shall be consid-
9 ered to be part of, the Park.

10 (3) AVAILABILITY OF FUNDS.—Any funds avail-
11 able for the Monument shall be available for the
12 Park.

13 (d) REFERENCES.—

14 (1) IN GENERAL.—Any reference in a law, map,
15 regulation, document, paper, or other record of the
16 United States to the “Chiricahua National Monu-
17 ment” shall be considered to be a reference to the
18 “Chiricahua National Park”.

19 (2) WILDERNESS.—Any reference in a law,
20 map, regulation, document, paper, or other record of
21 the United States to the “Chiricahua National
22 Monument Wilderness” designated by Public Law
23 94–567 (16 U.S.C. 1132 note; 90 Stat. 2692) shall
24 be considered to be a reference to the “Chiricahua
25 National Park Wilderness”.

1 (e) **ADMINISTRATION.**—The Secretary shall admin-
2 ister the Park in accordance with—

3 (1) ~~this Act, and~~

4 (2) the laws generally applicable to units of the
5 National Park System.

6 **SECTION 1. SHORT TITLE.**

7 *This Act may be cited as the “Chiricahua National*
8 *Park Act”.*

9 **SEC. 2. DESIGNATION OF CHIRICAHUA NATIONAL PARK, AR-**
10 **IZONA.**

11 (a) **DESIGNATION.**—

12 (1) **IN GENERAL.**—*The Chiricahua National*
13 *Monument in the State of Arizona established by*
14 *Presidential Proclamation 1692 (54 U.S.C. 320301*
15 *note; 43 Stat. 1946) shall be known and designated*
16 *as “Chiricahua National Park” (referred to in this*
17 *Act as the “National Park”).*

18 (2) **BOUNDARIES.**—*The boundaries of the Na-*
19 *tional Park shall be the boundaries of the Chiricahua*
20 *National Monument as of the date of enactment of*
21 *this Act, as generally depicted on the map entitled*
22 *“Chiricahua National Park Proposed Boundary”,*
23 *numbered 145/156,356, and dated March 2021.*

24 (3) **REFERENCES.**—*Any reference in a law, map,*
25 *regulation, document, or other record of the United*

1 *States to the Chiricahua National Monument shall be*
2 *considered to be a reference to the “Chiricahua Na-*
3 *tional Park”.*

4 (4) *AVAILABILITY OF FUNDS.—Any funds avail-*
5 *able for the Chiricahua National Monument shall be*
6 *available for the National Park.*

7 (b) *ADMINISTRATION.—The Secretary of the Interior*
8 *shall administer the National Park in accordance with—*

9 (1) *Presidential Proclamation 1692 (54 U.S.C.*
10 *320301 note; 43 Stat. 1946);*

11 (2) *Presidential Proclamation 2288 (54 U.S.C.*
12 *320301 note; 52 Stat. 1551); and*

13 (3) *the laws generally applicable to units of the*
14 *National Park System, including—*

15 (A) *section 100101(a), chapter 1003, and*
16 *sections 100751(a), 100752, 100753, and 102101*
17 *of title 54, United States Code; and*

18 (B) *chapter 3201 of title 54, United States*
19 *Code.*
