Mr. DURBIN (for himself and Ms. DUCKWORTH) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

## A BILL

To redesignate the Pullman National Monument in the State of Illinois as the Pullman National Historical Park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Pullman National His-  
5 torical Park Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

8 (1) HISTORICAL PARK.—The term “historical  
9 park” means the Pullman National Historical Park.

1           (2) MAP.—The term “map” means the map en-  
 2           titled “Pullman National Historical Park, Chicago,  
 3           Illinois, Boundary”, numbered \_\_\_\_\_, and dated  
 4           \_\_\_\_\_.

5           (3) SECRETARY.—The term “Secretary” means  
 6           the Secretary of the Interior.

7   **SEC. 3. REDESIGNATION OF PULLMAN NATIONAL MONU-**  
 8   **MENT.**

9           (a) IN GENERAL.—The Pullman National Monu-  
 10          ment, established by Proclamation Number 9233, dated  
 11          February 19, 2015, is redesignated as the “Pullman Na-  
 12          tional Historical Park.”.

13          (b) AVAILABILITY OF FUNDS.—Any funds available  
 14          for purposes of the Pullman National Monument shall be  
 15          available for purposes of the historical park.

16          (c) REFERENCES.—Any references in a law, regula-  
 17          tion, document, record, map, or other paper of the United  
 18          States to the Pullman National Monument shall be consid-  
 19          ered to be a reference to the historical park.

20          (d) PROCLAMATION.—Proclamation Number 9233,  
 21          dated February 19, 2015, shall have no force or effect.

22   **SEC. 4. PURPOSES.**

23          The purposes of the historical park are to preserve,  
 24          protect, and interpret Pullman’s nationally significant cul-  
 25          tural and historical resources associated with—

1 (1) the Nation’s labor history and creation of a  
2 national Labor Day holiday;

3 (2) the first planned industrial community in  
4 the United States;

5 (3) the architecture and landscape design of the  
6 planned community;

7 (4) the pivotal role of the Pullman porter in the  
8 rise of the African-American middle class; and

9 (5) the entirety of history, culture, and historic  
10 figures embodied in Presidential Proclamation Num-  
11 ber 9233.

12 **SEC. 5. ADMINISTRATION.**

13 The Secretary shall administer the land within the  
14 boundary of the historical park in accordance with—

15 (1) this Act; and

16 (2) the laws generally applicable to units of the  
17 National Park System, including—

18 (A) section 100101(a), chapter 1003, and  
19 sections 100751(a), 100752, 100753 and  
20 102101 of title 54, United States Code; and

21 (B) chapter 3201 of title 54, United States  
22 Code.

23 **SEC. 6. COOPERATIVE AGREEMENTS.**

24 To further the purposes of this subsection and not-  
25 withstanding chapter 63 of title 31, United States Code,

1 the Secretary may enter into cooperative agreements with  
2 the State, other public and non-profit entities, and other  
3 interested parties—

4           (1) to support collaborative interpretive and  
5 educational programs at non-Federal historic prop-  
6 erties within the boundaries of the historical park;  
7 and

8           (2) to identify, interpret, and provide assistance  
9 for the preservation of non-Federal land within the  
10 boundaries of the historical park and at sites in  
11 close proximity to the historical park, but located  
12 outside the boundaries of the historical park, includ-  
13 ing providing for placement of directional and inter-  
14 pretive signage, exhibits, and technology-based inter-  
15 pretive devices; and

16 **SEC. 7. USE OF FUNDS.**

17       The Secretary may use appropriated funds to mark,  
18 interpret, improve, restore, and provide technical assist-  
19 ance with respect to the preservation and interpretation  
20 of the properties. Any payment made by the Secretary  
21 under this clause shall be subject to an agreement that  
22 the conversion, use, or disposal of the project for purposes  
23 that are inconsistent with the purposes of this subsection,  
24 as determined by the Secretary, shall result in a right of  
25 the United States to reimbursement of the greater of—

1           (1) the amount provided by the Secretary to the  
2           project; or

3           (2) an amount equal to the increase in the  
4           value of the project that is attributable to the funds,  
5           as determined by the Secretary at the time of the  
6           conversion, use, or disposal. Any cooperative agree-  
7           ment entered into under this subparagraph shall  
8           provide for reasonable public access to the resources  
9           covered by the cooperative agreement.

10 **SEC. 8. ACQUISITION OF LAND.**

11           The Secretary may acquire for inclusion in the histor-  
12           ical park any land (including interests in land), buildings,  
13           or structures owned by the State, or any other political,  
14           private, or nonprofit entity by donation, transfer, ex-  
15           change, or purchase from a willing seller.

16 **SEC. 9. MANAGEMENT PLAN.**

17           Not later than 3 fiscal years after the date on which  
18           funds are first made available to carry out this Act, the  
19           Secretary shall complete a general management plan for  
20           the historical park.
