Mr. CRAMER (for himself and Mr. HOEVEN) introduced the following bill;
which was read twice and referred to the Committee on Energy and Nat-
ural Resources

A BILL

To make certain irrigation districts eligible for Pick-Sloan
Missouri Basin Program pumping power, and for other
purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ELIGIBILITY OF CERTAIN AREAS TO RECEIVE**
4 **PICK-SLOAN MISSOURI BASIN PROGRAM**
5 **PUMPING POWER.**

6 Section 5(a) of Public Law 89–108 (79 Stat. 435;
7 100 Stat. 419; 114 Stat. 2763A–284) is amended by add-
8 ing at the end the following:

1 “(6) ELIGIBILITY OF CERTAIN IRRIGATION DIS-
2 TRICTS TO RECEIVE PUMPING POWER.—

3 “(A) DEFINITION OF ELIGIBLE IRRIGA-
4 TION DISTRICT.—In this paragraph, the term
5 ‘eligible irrigation district’ means an irrigation
6 district that is located in—

7 “(i) the test area referred to in para-
8 graph (1); or

9 “(ii) an area within the 28,000-acre
10 area described in paragraph (3) that is
11 analyzed by the Secretary but not devel-
12 oped under that paragraph.

13 “(B) ELIGIBILITY.—An eligible irrigation
14 district shall be eligible to receive Pick-Sloan
15 Missouri Basin Program pumping power—

16 “(i) subject to any terms and at any
17 rates established by the Secretary; and

18 “(ii) in accordance with a contract en-
19 tered into under subparagraph (C).

20 “(C) CONTRACT.—

21 “(i) IN GENERAL.—Subject to clause
22 (ii), the Secretary may enter into a con-
23 tract with an eligible irrigation district to
24 provide Pick-Sloan Missouri Basin Pro-

1 gram pumping power to the eligible irriga-
2 tion district.

3 “(ii) REQUIREMENT.—No Pick-Sloan
4 Missouri Basin Program pumping power
5 may be delivered to an eligible irrigation
6 district under this paragraph until the date
7 on which a contract authorizing the deliv-
8 ery to the irrigation district is executed
9 under clause (i).”.
