A BILL

To amend the Rosie the Riveter/World War II Home Front National Historical Park Establishment Act of 2000 to provide for additional areas to be added to the park, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ROSIE THE RIVETER/WORLD WAR II HOME**
4 **FRONT NATIONAL HISTORICAL PARK ADDI-**
5 **TIONS.**

6 (a) SHORT TITLE.—This Act may be cited as the
7 “Rosie the Riveter National Historic Site Expansion Act”.

1 (b) ADDITIONS.—The Rosie the Riveter/World War
 2 II Home Front National Historical Park Establishment
 3 Act of 2000 (16 U.S.C. 410ggg et seq.) is amended as
 4 follows:

5 (1) In section 2(b), by adding at the end the
 6 following: “Not later than 180 days after areas are
 7 added to the park administratively or by Federal
 8 law, the Secretary shall update the map to include
 9 the added areas.”.

10 (2) By adding at the end of section 2, the fol-
 11 lowing:

12 “(c) ADDITIONAL AREAS INCLUDED.—In addition to
 13 areas included under subsection (b), the park shall include
 14 the following:

15 “(1) The Nystrom Elementary School—The
 16 Maritime Building, as listed on the National Reg-
 17 ister of Historic Places.

18 “(2) Such other areas as the Secretary deems
 19 appropriate.”.

20 (3) By amending section 3(e)(2) to read as fol-
 21 lows:

22 “(2) OTHER PROPERTY.—Within the bound-
 23 aries of the park, the Secretary may acquire lands,
 24 improvements, waters, or interests therein, by dona-
 25 tion, purchase, exchange or transfer. Any lands, or

1 interests therein, owned by the State of California or
2 any political subdivision thereof, may be acquired
3 only by donation. When any tract of land is only
4 partly within such boundaries, the Secretary may ac-
5 quire all or any portion of the land outside of such
6 boundaries in order to minimize the payment of sev-
7 erance costs. Land so acquired outside of the bound-
8 aries may be exchanged by the Secretary for non-
9 Federal lands within the boundaries. Any portion of
10 land acquired outside the boundaries and not used
11 for exchange shall be reported to the General Serv-
12 ices Administration for disposal for not less than
13 fair market value under chapter 1 of title 40, United
14 States Code.”.
