Mr. HAWLEY introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To establish a separate criminal offense for targeting an individual based on their status as law enforcement officer.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROTECTING LAW ENFORCEMENT OFFICERS**

4 **FROM TARGETING.**

5 (a) AMENDMENT.—Chapter 7 of title 18, United
6 States Code, is amended by adding at the end the fol-
7 lowing:

8 **“§ 120. Crimes targeting law enforcement officers**

9 “(a) OFFENSE.—Whoever, in any circumstance de-
10 scribed in subsection (b), knowingly causes bodily injury

1 to any person, or attempts to do so, because of the actual
2 or perceived status of the person as a law enforcement
3 officer—

4 “(1) shall be imprisoned not more than 20
5 years, fined in accordance with this title, or both;
6 and

7 “(2) shall be imprisoned for any term of years
8 or for life, fined in accordance with this title, or
9 both, if—

10 “(A) death results from the offense; or

11 “(B) the offense includes kidnapping or an
12 attempt to kidnap, or an attempt to kill.

13 “(b) CIRCUMSTANCES DESCRIBED.—For purposes of
14 subsection (a), the circumstances described in this sub-
15 section are that—

16 “(1) the conduct described in subsection (a) oc-
17 curs during the course of, or as the result of, the
18 travel of the defendant or the victim—

19 “(A) across a State line or national border;

20 or

21 “(B) using a channel, facility, or instru-
22 mentality of interstate or foreign commerce;

23 “(2) the defendant uses a channel, facility, or
24 instrumentality of interstate or foreign commerce in

1 connection with the conduct described in subsection
2 (a);

3 “(3) in connection with the conduct described in
4 subsection (a), the defendant employs a firearm,
5 dangerous weapon, explosive or incendiary device, or
6 other weapon that has traveled in interstate or for-
7 eign commerce; or

8 “(4) the conduct described in subsection (a)—

9 “(A) interferes with commercial or other
10 economic activity in which the victim is engaged
11 at the time of the conduct; or

12 “(B) otherwise affects interstate or foreign
13 commerce.

14 “(c) DEFINITIONS.—In this section:

15 “(1) LAW ENFORCEMENT OFFICER.—The term
16 ‘law enforcement officer’ means an employee of a
17 governmental or public agency who is authorized by
18 law—

19 “(A) to engage in or supervise the preven-
20 tion, detention, investigation, or the incarcer-
21 ation of any person for any criminal violation of
22 law; and

23 “(B) to apprehend or arrest a person for
24 any criminal violation of law.

1 “(2) STATE.—The term ‘State’ includes the
2 District of Columbia, Puerto Rico, and any other
3 territory or possession of the United States.”.

4 (b) CLERICAL AMENDMENT.—The table of sections
5 for chapter 7 of title 18, United States Code, is amended
6 by adding at the end the following:

“120. Crimes targeting law enforcement officers.”.
