Mr. BLUNT (for himself and Mr. HAWLEY) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To modify the boundary of the Wilson’s Creek National Battlefield in the State of Missouri, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Wilson’s Creek Na-
5 tional Battlefield Boundary Revision Act of 2021”.

6 **SEC. 2. WILSON’S CREEK NATIONAL BATTLEFIELD BOUND-** 7 **ARY MODIFICATION.**

8 Section 1(b) Public Law 86–434 (16 U.S.C.
9 430kk(b)) is amended—

10 (1) in paragraph (1)—

1 (A) in the second sentence, by striking
 2 “The map” and inserting the following:

3 “(C) AVAILABILITY OF MAPS.—The maps
 4 described in subparagraphs (A) and (B)”;

5 (B) by striking “(1) The boundaries” and
 6 inserting the following:

7 “(1) ADDITIONAL LAND.—

8 “(A) IN GENERAL.—The boundaries”;

9 (C) by inserting after subparagraph (A)
 10 (as so designated) the following:

11 “(B) NEWTONIA BATTLEFIELD ADDI-
 12 TION.—The boundary of the Wilson’s Creek
 13 National Battlefield is revised to include the ap-
 14 proximately 624 acres of land identified as
 15 ‘Proposed Addition’ on the map entitled ‘Wil-
 16 son’s Creek National Battlefield Proposed
 17 Boundary Modification’, numbered 410/
 18 177,379, and dated September 2021.”; and

19 (D) by adding at the end the following:

20 “(D) ERRORS.—The Secretary of the Inte-
 21 rior may correct any clerical or typographical
 22 error in a map described in subparagraph (A)
 23 or (B).”; and

24 (2) in paragraph (2)—

1 (A) by striking “(2) The Secretary is au-
2 thorized to acquire the lands referred to in
3 paragraph (1)” and inserting the following:

4 “(2) METHOD OF ACQUISITION.—The Secretary
5 of the Interior may acquire the land described in
6 subparagraphs (A) and (B) of paragraph (1)”; and

7 (B) in the second sentence, by striking
8 “park” and inserting “Wilson’s Creek National
9 Battlefield”.
