

In the House of Representatives, U. S.,

November 29, 2022.

Resolved, That the bill from the Senate (S. 3846) entitled “An Act to reauthorize the Justice and Mental Health Collaboration Program, and for other purposes.”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “Justice and Mental*
3 *Health Collaboration Reauthorization Act of 2022”.*

4 ***SEC. 2. REAUTHORIZATION OF THE JUSTICE AND MENTAL***
5 ***HEALTH COLLABORATION PROGRAM.***

6 *Section 2991(b)(5) of title I of the Omnibus Crime*
7 *Control and Safe Streets Act of 1968 (34 U.S.C.*
8 *10651(b)(5)) is amended—*

9 *(1) in subparagraph (I)—*

10 *(A) in clause (i), by striking “teams and*
11 *treatment accountability services for commu-*
12 *nities” and inserting “teams, treatment account-*
13 *ability services for communities, and training*
14 *for State and local prosecutors relating to diver-*
15 *sion programming and implementation”;*

1 (B) in clause (v)—

2 (i) in subclause (III), by striking
3 “and” at the end;

4 (ii) in subclause (IV), by striking the
5 period at the end and inserting “; and”;
6 and

7 (iii) by adding at the end the fol-
8 lowing:

9 “(V) coordinate, implement, and
10 administer models to address mental
11 health calls that include specially
12 trained officers and mental health cri-
13 sis workers responding to those calls to-
14 gether.”; and

15 (C) by adding at the end the following:

16 “(vi) *SUICIDE PREVENTION SERV-*
17 *ICES.—Funds may be used to develop, pro-*
18 *mote, and implement comprehensive suicide*
19 *prevention programs and services for incar-*
20 *cerated individuals that include ongoing*
21 *risk assessment.*

22 “(vii) *CASE MANAGEMENT SERVICES.—*
23 *Funds may be used for case management*
24 *services for preliminary qualified offenders*

1 *and individuals who are released from any*
2 *penal or correctional institution to—*

3 “(I) *reduce recidivism; and*

4 “(II) *assist those individuals with*
5 *reentry into the community.*

6 “(viii) *ENHANCING COMMUNITY CAPAC-*
7 *ITY AND LINKS TO MENTAL HEALTH*
8 *CARE.—Funds may be used to support, ad-*
9 *minister, or develop treatment capacity and*
10 *increase access to mental health care and*
11 *substance use disorder services for prelimi-*
12 *nary qualified offenders and individuals*
13 *who are released from any penal or correc-*
14 *tional institution.*

15 “(ix) *IMPLEMENTING 988.—Funds may*
16 *be used to support the efforts of State and*
17 *local governments to implement and expand*
18 *the integration of the 988 universal tele-*
19 *phone number designated for the purpose of*
20 *the national suicide prevention and mental*
21 *health crisis hotline system under section*
22 *251(e)(4) of the Communications Act of*
23 *1934 (47 U.S.C. 251(e)(4)), including by*
24 *hiring staff to support the implementation*
25 *and expansion.”; and*

1 (2) *by adding at the end the following:*

2 “(K) *TEAMS ADDRESSING MENTAL HEALTH*
 3 *CALLS.—With respect to a multidisciplinary*
 4 *team described in subparagraph (I)(v) that re-*
 5 *ceives funds from a grant under this section, the*
 6 *multidisciplinary team—*

7 “(i) *shall, to the extent practicable,*
 8 *provide response capability 24 hours each*
 9 *day and 7 days each week to respond to cri-*
 10 *sis or mental health calls; and*

11 “(ii) *may place a part of the team in*
 12 *a 911 call center to facilitate the timely re-*
 13 *sponse to mental health crises.”.*

14 **SEC. 3. EXAMINATION AND REPORT ON PREVALENCE OF**
 15 **MENTALLY ILL OFFENDERS.**

16 *Section 5(d) of the Mentally Ill Offender Treatment*
 17 *and Crime Reduction Reauthorization and Improvement*
 18 *Act of 2008 (Public Law 110–416; 122 Stat. 4355) is*
 19 *amended by striking “2009” and inserting “each of fiscal*
 20 *years 2023 through 2027”.*
