# **A BILL**

To require the Director of the Bureau of Land Management to withdraw a rule of the Bureau of Land Management relating to conservation and landscape health.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Western Economic Secu-*  
5 *rity Today Act of 2023” or the “WEST Act of 2023”.*

6 **SEC. 2. WITHDRAWAL OF BLM PROPOSED RULE.**

7        *The Director of the Bureau of Land Management—*

8            *(1) shall withdraw the proposed rule of the Bu-*  
9            *reau of Land Management entitled “Conservation and*  
10           *Landscape Health” (88 Fed. Reg. 19583 (April 3,*  
11           *2023)); and*

12           *(2) shall not take any action to finalize, imple-*  
13           *ment, or enforce the proposed rule described in para-*  
14           *graph (1) or any substantially similar rule.*
