## AN ACT

To direct the Secretary of State to establish a national registry of Korean American divided families, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Korean American Di-  
3 vided Families National Registry Act”.

4 **SEC. 2. NATIONAL REGISTRY OF KOREAN AMERICAN DI-**  
5 **VIDED FAMILIES.**

6       The Secretary of State, acting through the Special  
7 Envoy on North Korean Human Rights Issues or such  
8 other individual as the Secretary may designate, shall—

9           (1) collate information on Korean American  
10 families who wish to be reunited with family mem-  
11 bers in North Korea from which such Korean Amer-  
12 ican families were divided after the signing of the  
13 Agreement Concerning a Military Armistice in  
14 Korea, signed at Panmunjom July 27, 1953 (com-  
15 monly referred to as the “Korean War Armistice  
16 Agreement”), in anticipation of future reunions for  
17 such families and family members, including in-per-  
18 son and video reunions; and

19           (2) establish a private internal national registry  
20 of the names and other relevant information of such  
21 Korean American families—

22           (A) to host such future reunions in South  
23 Korea, the United States, or third countries;  
24 and

25           (B) to provide for a private internal reposi-  
26 tory of information about such Korean Amer-

1           ican families and family members in North  
2           Korea, including information about individuals  
3           who may be deceased.

4   **SEC. 3. ACTIONS TO FACILITATE DIALOGUE BETWEEN THE**  
5                   **UNITED STATES AND NORTH KOREA.**

6           (a) IN GENERAL.—The Secretary of State shall take  
7   such actions as may be necessary to ensure that any direct  
8   dialogue between the United States and North Korea in-  
9   cludes progress towards holding future reunions for Ko-  
10   rean American families and their family members in North  
11   Korea as described in section 2.

12          (b) CONSULTATIONS.—The Secretary of State shall  
13   consult with the Government of the Republic of Korea in  
14   carrying out this section.

15          (c) REPORT.—No later than one year after enact-  
16   ment of this Act, and annually thereafter for 5 years, the  
17   Secretary of State shall submit to the appropriate congres-  
18   sional committees a report on—

19               (1) the status of the national registry estab-  
20   lished pursuant to section 2(a)(2);

21               (2) the number of individuals included on the  
22   registry who—

23                       (A) have met their family members in  
24   North Korea during previous reunions; and

1 (B) have yet to meet their family members  
2 in North Korea during previous reunions;

3 (3) a summary of responses by North Korea to  
4 requests to hold reunions of divided families; and

5 (4) a description of regulations in North Korea  
6 and actions taken by North Korea in the year pre-  
7 vious to submission of each report that prevent the  
8 emigration of family members of Korean American  
9 families.

10 (d) APPROPRIATE CONGRESSIONAL COMMITTEES  
11 DEFINED.—In this Act, “appropriate congressional com-  
12 mittees” means the Committee on Foreign Affairs of the  
13 House of Representatives and the Committee on Foreign  
14 Relations of the Senate.
