### 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Jackie Robinson Ball-
- 3 park National Commemorative Site Act".
- 4 SEC. 2. JACKIE ROBINSON BALLPARK NATIONAL COM-
- 5 **MEMORATIVE SITE.**
- 6 (a) Definitions.—In this Act:
- 7 (1) Secretary.—The term "Secretary" means
- 8 the Secretary of the Interior.
- 9 (2) Site.—The term "Site" means the Jackie
- 10 Robinson Ballpark National Commemorative Site
- designated by subsection (b).
- 12 (3) STATE.—The term "State" means the State
- of Florida.
- 14 (b) Designation.—Jackie Robinson Ballpark in
- 15 Daytona Beach, Florida, is hereby designated as the Jack-
- 16 ie Robinson Ballpark National Commemorative Site.
- 17 (c) African American Civil Rights Network.—
- 18 The Site shall be part of the African American Civil
- 19 Rights Network established under the African American
- 20 Civil Rights Network Act of 2017 (Public Law 115–104).
- 21 (d) Administration.—
- 22 (1) Cooperative agreements.—The Sec-
- retary may enter into cooperative agreements with
- 24 appropriate public or private entities for interpreta-
- 25 tive and educational purposes related to the Site.

1	(2) Effect of Designation.—The Site shall				
2	not be a unit of the National Park System.				
3	(3) Limitations.—Nothing in this Act—				
4	(A) authorizes the Secretary to interfer				
5	with the rights of any person with respect to				
6	private property or any local zoning ordinance				
7	or land use plan of the State or any politica				
8	subdivision thereof;				
9	(B) affects the administration of the Site				
10	by any owner of the Site; or				
11	(C) authorizes the Secretary to acquire				
12	land or interests in land through condemnation				
13	or otherwise.				
14	(e) Special Resource Study.—				
15	(1) IN GENERAL.—The Secretary shall conduct				
16	a special resource study of the Site to evaluate the				
17	national significance of the Site and determine the				
18	suitability and feasibility of designating the Site as				
19	a unit of the National Park System.				
20	(2) Alternatives.—The Secretary shall con-				
21	sider alternatives for preservation, protection, and				
22	interpretation of the Site by Federal, State, or local				
23	government entities, or private and nonprofit organi-				

zations.

	(3) CONDUCT OF STUDY.—The study shall be
2	conducted in accordance with section 100507 of title
3	54, United States Code.

4 (4) REPORT.—Not later than 2 years after the
5 date on which funds are made available to conduct
6 the study, the Secretary shall submit a report to
7 Congress that describes the results of the study and
8 any recommendations of the Secretary with respect
9 to the Site.
