A BILL

To require the Secretary of the Interior to conduct a study to assess the suitability and feasibility of designating certain land as the Lahaina National Heritage Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Lahaina National Her-*
5 *itage Area Study Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *SECRETARY.*—*The term “Secretary” means*
9 *the Secretary of the Interior.*

10 (2) *STATE.*—*The term “State” means the State*
11 *of Hawaii.*

12 (3) *STUDY AREA.*—*The term “study area” means*
13 *the census-designated place of Lahaina in Maui*
14 *County in the State.*

15 **SEC. 3. LAHAINA NATIONAL HERITAGE AREA STUDY.**

16 *The Secretary, in coordination with the County of*
17 *Maui and in consultation with State and local historic*
18 *preservation officers, State and local historical societies,*
19 *State and local tourism offices, and other appropriate orga-*
20 *nizations and governmental agencies, shall carry out, in ac-*
21 *cordance with section 120103(a) of title 54, United States*
22 *Code, a study to assess the suitability and feasibility of des-*
23 *ignating the study area as a National Heritage Area, to*
24 *be known as the “Lahaina National Heritage Area”.*
