A BILL

To amend the Homeland Security Act of 2002 to direct the Under Secretary for Intelligence and Analysis of the Department of Homeland Security to conduct an annual audit of the information systems and bulk data of the Office of Intelligence and Analysis of the Department, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “DHS Intelligence and
5 Analysis Oversight and Transparency Act”.

6 **SEC. 2. ANNUAL AUDIT OF DHS OFFICE OF INTELLIGENCE**
7 **AND ANALYSIS INFORMATION SYSTEMS AND**
8 **BULK DATA.**

9 (a) IN GENERAL.—Subtitle A of title II of the Home-
10 land Security Act of 2002 (6 U.S.C. 121 et seq.) is amend-
11 ed by adding at the end the following new section:

12 **“SEC. 210H. ANNUAL AUDIT OF INFORMATION SYSTEMS**
13 **AND BULK DATA.**

14 “(a) IN GENERAL.—The Under Secretary for Intel-
15 ligence and Analysis of the Department shall conduct an
16 annual audit of the information systems and bulk data of
17 the Office of Intelligence and Analysis, which shall be con-
18 sistent with the intelligence oversight guidelines of the Of-
19 fice of Intelligence and Analysis.

20 “(b) REPORT.—Not later than 30 days after the con-
21 clusion of the audit under subsection (a), the Under Sec-
22 retary for Intelligence and Analysis of the Department
23 shall submit to the appropriate congressional committees
24 the findings and results of such audit.

1 “(c) DEFINITION.—In this section, the term ‘appro-
2 pate congressional committees’ means the Committee on
3 Homeland Security and the Permanent Select Committee
4 on Intelligence of the House of Representatives and the
5 Committee on Homeland Security and Governmental Af-
6 fairs and the Select Committee on Intelligence of the Sen-
7 ate.”.

8 (b) CLERICAL AMENDMENT.—The table of contents
9 in section 1(b) of the Homeland Security Act of 2002 is
10 amended by inserting after the item relating to section
11 210G the following new item:

“Sec. 210H. Annual audit of information systems and bulk data.”.
