## A BILL

To require each Member of Congress and the President and Vice President to complete a program of training in handling and safeguarding classified information, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Information Security  
5 Investment Act of 2023”.

1 **SEC. 2. MANDATORY COMPLETION OF CLASSIFIED INFOR-**  
2 **MATION TRAINING FOR MEMBERS OF CON-**  
3 **GRESS.**

4 (a) REQUIREMENT.—Not later than 30 days after the  
5 date of the enactment of this Act, the Committee on  
6 House Administration of the House of Representatives  
7 and the Committee on Rules and Administration of the  
8 Senate shall issue regulations to require each Member of  
9 the House of Representatives and each Member of the  
10 Senate, respectively, to complete a program of training in  
11 handling and safeguarding classified information during  
12 each Congress.

13 (b) DEADLINE.—

14 (1) IN GENERAL.—Under the regulations issued  
15 by the Committee on House Administration of the  
16 House of Representatives and the Committee on  
17 Rules and Administration of the Senate under sub-  
18 section (a), an individual shall complete the program  
19 of training required under such subsection and file  
20 a certificate of completion of such training—

21 (A) in the case of an individual who is  
22 serving as a Member of the House of Rep-  
23 resentatives or the Senate as of the date of the  
24 first day of the first session of a Congress, not  
25 later than 90 days after such date; or

1 (B) in the case of any other individual, not  
2 later than 90 days after the date the individual  
3 first becomes a Member of the House of Rep-  
4 resentatives or the Senate during a Congress.

5 (2) SPECIAL RULE FOR FIRST SESSION OF ONE  
6 HUNDRED EIGHTEENTH CONGRESS.—In the case of  
7 the first session of the One Hundred Eighteenth  
8 Congress, an individual described in subparagraph  
9 (A) of paragraph (1) shall complete the program of  
10 training required under subsection (a) not later than  
11 180 days after the date of the enactment of this Act.

12 (c) MEMBER OF THE HOUSE OF REPRESENTATIVES  
13 DEFINED.—In this section, the term “Member of the  
14 House of Representatives” includes a Delegate or Resi-  
15 dent Commissioner to the Congress.

16 (d) EXERCISE OF RULEMAKING POWERS.—The pro-  
17 visions of this section are enacted by the Congress—

18 (1) as an exercise of the rulemaking power of  
19 the House of Representatives and the Senate, re-  
20 spectively, and as such they shall be considered as  
21 part of the rules of each House, respectively, or of  
22 that House to which they specifically apply, and  
23 such rules shall supersede other rules only to the ex-  
24 tent that they are inconsistent therewith; and

1           (2) with full recognition of the constitutional  
2           right of either House to change such rules (so far  
3           as relating to such House) at any time, in the same  
4           manner, and to the same extent as in the case of  
5           any other rule of such House.

6 **SEC. 3. MANDATORY COMPLETION OF CLASSIFIED INFOR-**  
7 **MATION TRAINING FOR PRESIDENT AND**  
8 **VICE PRESIDENT.**

9           (a) IN GENERAL.—Not later than 30 days after the  
10          date of the enactment of this Act, the Director of the Of-  
11          fice of Personnel Management shall designate an appro-  
12          priate agency or department of the Federal Government  
13          to develop and provide a program of training in handling  
14          and safeguarding classified information to the President  
15          and Vice President.

16          (b) DEADLINE.—

17                 (1) IN GENERAL.—The President and Vice  
18          President shall each complete the program of train-  
19          ing described in subsection (a) not later than 30  
20          days after the date each such individual begins serv-  
21          ing a term as President or Vice President, and every  
22          two years thereafter while each such individual con-  
23          tinues to serve as President or Vice President.

24                 (2) SPECIAL RULE FOR FIRST TRAINING.—The  
25          President and Vice President shall each, not later

1       than 180 days after the date of the enactment of  
2       this Act, complete the program of training described  
3       in subsection (a).
